CONSOLIDATION ORDERS - PAY AND DISPLAY, DISABLED PERSON'S AND MOTOR CYCLE PARKING

1. NOTICE IS HEREBY GIVEN that the Common Council of the City of London on 18 October 2013 made orders under section 6 and section 45 of the Road Traffic Regulation Act 1984.

2. The effect of the orders will be to consolidate:

- (a) the City of London (Parking Places) (No.3) Order 2011 and amending orders;
- (b) the City of London (Free Parking Places) (Disabled Persons) (No.4) Order 2010 and amending orders; and
- (c) the City of London (Free Parking Places) (Motor Cycles) (No.3) Order 2010 and amending orders.
