Westminster, October 9.

THIS Day His Majesty came to the House of Peers, and being in his Royal Robes seated on the Throne with the usual Solemnity, Sir William Sanderfon Gentleman-Usher of the Black-Rod, was sent with a Message to the House of Commons, commanding their Attendance in the House of Peers: The Commons being come thither, His Majesty's Pleasure was signified to them by the Lord Chancellor, that they should return to their House and chuse a Speaker, and present him to His Majesty on Thursday next. They returned accordingly, and unanimously chose the Honourable Spencer Compton, Esq; to be their Speaker.

Whitehall, Oct. 8. An humble Address of the High Sheriff, Justices of the Peace, and Grand Jury assembled at the Quarter-Sessions of the Peace holden at Maidstone, in the County of Kent, the 2d Day of this Instant October, has been presented to His Majesty by Peter Burrell, Esq; High Sheriff, and Roger Meredith, Esq; with several Members of Parliament and Gentlemen of that County, introduced by the Right Honourable the Lord Viscount Townshend one of His Majesty's Principal Secretaries of State: Which Address His Majesty was pleased to receive very graciously, and all the Gentlemen had the Honour to kiss His Majesty's Hand.

Lisbon, Sept. 30, N. S. Letters from Cadiz of the 21st Instant advise, that the Dutch Squadron of Men of War was returned into that Bay from cruising against the Algerines, and that the Spanish Squadron was daily expected there from Alicant: The Governour of Cadiz had received Intelligence, that the Turkish Sultanas had anchored off Roses in Catalonia; but had not attempted the least Act of Hostility there.

Turin, Oct. 3, N. S. The Count de Franca Villa, a Sicilian Nobleman, has made the Princess a Present of eight white Mules for her Coach. The Count de Santa Croce, formerly Viceroy of Sardinia, and left as Hostage for the Cannon the Spaniards carried from thence, having obtained Leave to come Home on his Parole, returned hither last Monday, and brought his Family with him. Last Monday the Camp broke up; and at the same Time the Prince of Piemont made a Compliment of his Horse and Furniture to the Collonel of his own Regiment the Count de la Perouse: His Royal Highness also presented each Officer of that Regiment with a Silver-hilted Sword. On Wednesday the 30th of September the Court left Rivoli. His Sardinian Majesty arrived here the same Morning, and after Dinner made a Visit to Madame Royale, and then went to the Veneria. The same Day the Queen, with the Prince and Princess, dined at Collin in a Convent of Chartreux-Fryars, and afterwards went to his Majesty at the Veneria, where they intend to pass the Autumn.

Paris, Oct. 14. The King will come hither from Versailles the 16th Instant in the Evening, and the next Day will set out for Rheims, where according to the Route settled his Majesty will arrive the 22d, and the Ceremony of his Coronation will be performed the 25th: On the 30th his Majesty is to leave Rheims, and returning by Villers Cotterets is to be entertained there by the Duke of Orleans, and at Chantilly by the Duke of Bourbon, and will be back here the 9th of next Month. We have Letters from Rome of the 26th of September, N. S. which advise that in a Consistory held the 23d several Bishops were approved; but the Promotion of Cardinals which was then expected to have been declared, was further suspended till a greater Number of Seats in that College should become vacant. The Ambassadour of Malta had communicated to the Court of Rome the agreeable News of the taking of two Cruisers of Tripoli off Cape Passaro by the Maltese; the Crews of those Prizes consisting of 372 Men. Mon. Sig. Aldovrandi had been under Examination three Hours about Cardinal Alberoni's Affairs, and on the 27th a Congregation was to be held on that Subject in Cardinal Barbarini's Palace; the Process against the said Cardinal Alberoni being still kept on foot. On the 21st an Express from the Court of Vienna brought Dispatches to Cardinal Cienfuegos at Rome, and proceeded for Naples and Sicily with Orders to the Imperial Vice-roys of those Kingdoms.

also receive the Reward of Two Hundred Pounds for each Offender so convicted, to be paid as aforesaid.
