(AMENDMENT NO 3) TRAFFIC ORDER 2015

THE BEXLEY (PROHIBITION OF STOPPING OUTSIDE SCHOOLS)

(AMENDMENT NO 5) TRAFFIC ORDER 2015.

1. **NOTICE IS HEREBY GIVEN** that the Council of the London Borough of Bexley, have on 19th October, 2015 made the above mentioned Traffic Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985 and all other enabling powers.

2. The general effect of the Bexley (Waiting and Loading Restriction) (Amendment No 3) Traffic Order 2015 would be to further amend the Bexley (Waiting and Loading Restriction) Traffic Order 2015 no. 68 to:

—

(a) Introduce new 'At any time' no waiting restrictions in parts of Abbey Road, Abbey Wood; Clovelly Road, Belvedere; Danson Road, Bexleyheath; Gilbert Road, Belvedere; Kentish Road, Belvedere; Little Brights Road, Belvedere; Main Road, Sidcup; Manor Road; Erith; Northumberland Avenue, Welling; Oakley Park, Bexley; Oakway Close, Bexleyheath; Picardy Road, Belvedere; St Augustine's Road, Belvedere; Viewfield Road, Bexley;

(b) Add lengths of waiting and loading restrictions in Albert Road, Belvedere; Broomfield Road, Bexleyheath; Burnt Oak Lane, Sidcup; Chapel Road, Bexleyheath; Colyers Lane, Erith; Days Lane, Sidcup; Halfway Street, Sidcup; Hurst Road, Erith; Hurst Road, Sidcup; Lovel Avenue, Welling; Mayplace Road East, Bexleyheath; Service Road, Bexleyheath; Slade Green Road, Erith; Steynton Avenue, Bexley; Tower Park Road, Crayford; Woodbine Road, Sidcup; Woolwich Road, Bexleyheath; without physically changing any existing markings on street;

(c) Remove existing 'At any time' waiting restrictions in part of Sheldon Road, Bexleyheath;

(d) Replace 'Mon – Fri 10.00am – 12.00 noon' no waiting restrictions with 'At any time' no waiting restrictions on the east side of Pickford Road, Bexleyheath in the vicinity of Nos. 5, 7 and 9 Pickford Road.

3. The general effect of the Bexley (Prohibition of Stopping Outside Schools) (Amendment No 5) Traffic Order 2015 will be to add a further length of 'Mon – Fri 8.00am – 4.30pm' no stopping school zig zag restrictions in Sheldon Road, Bexleyheath;

4. Copies of the Orders which come into operation on 26th October 2015, the Bexley (Waiting and Loading Restriction) Traffic Order 2015 (and the Orders that have amended that Order); The Bexley (Prohibition of Stopping Outside Schools) Traffic Order 2013; the Council's Statement of Reasons for making the Orders and plans which indicate the lengths of roads to which the Orders relate can be inspected during normal office hours on Mondays to Fridays inclusive, at the Contact Centre, 2 Watling Street, Bexleyheath, Kent DA6 7AT.

6. Persons desiring to question the validity of the Order or any provision contained therein on the grounds that it is not made within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made under has not been complied with in relation to the Order, may make application for the purpose to the High Court before the expiration of 6 weeks from the date on which the Order is made.
