YORKSHIRE DALES NATIONAL PARK (DESIGNATION) (VARIATION) ORDER 2012

Notice is hereby given that on the 23rd day of October 2015 the Secretary of State for Environment, Food and Rural Affairs, confirmed without modifications the Lake District National Park (Designation) (Variation) Order 2012.

Notice is hereby given that on the 23rd day of October 2015 the Secretary of State for Environment, Food and Rural Affairs, confirmed with modifications the Yorkshire Dales National Park (Designation) (Variation) Order 2012.

The confirmed Orders may be cited as the Lake District National Park (Designation) (Variation) Confirmation Order 2015 and the Yorkshire Dales National Park (Designation) (Variation) Confirmation Order 2015.

The effect of these Confirmation Orders is to constitute the land to which the Orders relate as National Park. The Orders become operative as from the 1st day of August 2016, but if any person aggrieved by the Orders desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks and Access to the Countryside Act 1949 (as amended), or on the ground that any requirement of the Act or of any regulation made thereunder has not been complied with in relation to the making or confirmation of the Orders, he/she may, within six weeks from the date of publication of this notice, or by the 14th day of December 2015, whichever is the later, make an application to the High Court.

A certified copy of both of the Orders, and the maps contained therein, as confirmed by the Secretary of State, will be deposited at each of the places mentioned below, and will be open for inspection free of charge from the 2nd day of November 2015 until 14th day of December 2015 at the hours shown:
