Carers (Scotland) Act 2016: 2016 asp 9. - iii, 24, [1]p.: 30 cm. - Royal assent, 9th March 2016. An Act of the Scottish Parliament to make provision about carers, including the identification of carers' needs for support adult carer support plans and young carer statements; the provision of support to carers; the enabling of carer involvement in certain services; the preparation of local carer strategies; the establishment of information and advice services for carers.
