Westminster City Council hereby gives notice pursuant to section 252 of the Town and Country Planning Act 1990 that on 2 July 2018 it made the City of Westminster (Stopping Up of Highways) (No.2) Order 2018 under sub-section 247 (2A) of the Town and Country Planning Act 1990 ("the 1990 Act"), the general effect of which is to authorise the stopping up of parts of the highways Oxford Street and Woodstock Street to enable development to be carried out at the buildings Barratt House, 341-349 Oxford Street, London W1C 2JE and 8 Woodstock Street, London, W1C 2AD
