*Cambray, Jan. 24, N. S.* At a Conference held here on the 21st Instant, the Imperial Ministers acquainted the Ministers of Great Britain and France, that they had received from the Emperor the Original Act of Investiture for the Duchies of Tuscany, Parma, and Placentia, in favour of the Prince Don Carlos, Infant of Spain, which Act they declared they were authorized to deliver to the Ministers of Spain, pursuant to the Treaty of the Quadruple Alliance. The Ministers of Spain having been made acquainted therewith by those of Great Britain and France, and all the necessary Forms on this Occasion having been gone thorough by the several Parties concerned, at a Meeting this Day the Imperial Ministers did, in the Presence of those of Great Britain and France, deliver the said Original Act of Investiture in due Form to the Ministers of Spain authorized to receive the same.
