BRYANSTON MEWS EAST AND MONTAGU PLACE THE CITY OF WESTMINSTER (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 532) ORDER 2024

1. NOTICE IS HEREBY GIVEN that Westminster City Council on 22nd April 2024 made the above Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Order will be to introduce double yellow line "at any time" waiting restrictions on:

(a) Bryanston Mews East:

(i) the south-west side, from its junction with Montagu Place, extending south-eastward for a distance of 14 metres;
