N Thursday the 9th Instant the King of Sweden, accompanied by Field Marshal Count Ducker, Lieutenant General Cron-Redt, and some other Officers, went down to view the new Fortifications that are making at the Caftle of Waxholm, which guards the most important Passage of the River up to this City, and on Saturday in the Evening his Majesty returned to the Palace of Carlberg. The same Day a Muscothe Palace of Carlberg. The same Day a Musco-vite Ship arrived here with some of Baron Cederhielm's Servants and others of his Retinue, who give an Account, that on the 3d of this Month they saw the British Squadron under the Command of Sir Charles Wager, lying at Anchor within a League of Revel; they also report, that some Days before they met a Frigate with British Co-lours standing towards Cronslot: And by Letters from Petersbourg of the 3d of this Month, which came two Days ago by the ordinary Finnish Mail, we have Advice that his Britannick Majesty's Ship the Port Mahon was come to Cronflot, and had brought a Letter from his Majesty to the Czarina, which was fent up to Petersbourg. It was faid the Czarina intended to fend an Answer to Ad-

miral Wager, by a Frigate of her own.

Hague, July 9, N. S. The States of the Province of Holland having defisted from the several Points which had hitherto retarded the settling of the Act of Accession of this Republick to the Treaty of Hanover, the British French and Prussian Ministers were invited Yesterday to a Conference with the Deputies of the States-General, in which the Act of Accession as agreed to by the said Province was communicated to them, which being intirely approved, there is no room left to doubt but that this Affair will in a short time be brought to a final Conclusion.
