Madrid, July 8, N. S.

HIS Catholick Majesty has named Father Joseph Garcia, who was General of the Franciscan Order of Fryars, to the Bishoprick of Siguenza, which was vacant by the Death of Don Juan de Herrera late President of Castille; and has likewise preferred Don Pedro de Copons Archdeacon of the Cathedral Church of Barcelona, to the Bishoprick of Girona. On the 2d Instant the Queen of Spain went, for the first Time since her lying in, to Mass in the Royal Chapel of the Palace; her Majesty continues in good Health. His Catholick Majesty has declared that a Bull-Feast shall be performed in the Plaza-Mayor on the 23d Instant, and that on the 27th he will remove with the Royal Family to St. Ildefonso, in order to reside there for some Weeks. The Count d'Aguilar, a Grandee of Spain, and Captain General in his Catholick Majesty's Army, who some Years since was under his Catholick Majesty's Displeasure, and was exiled, having been lately recalled from his Banishment, went to Court on the 6th Instant in the Evening, and kiss'd his Catholick Majesty's Hand, thanking him for his gracious Pardon. The said Count being in a very bad State of Health, designs to go soon to use the Baths of Ledesma. Letters of the 2d Instant from Cadiz advise, that four Spanish Gallies had come in there and disembarked three Batallions of the Garrison of Ceuta, which had been relieved by an equal Number of Troops brought thither from Malaga by the said Gallies.

Whitchall, July 18. On the 16th Instant arrived a Messenger, who was dispatched by Sir Charles Wager from the Bay of Revel on the 25th of June, O. S. On the 24th the Raphael a Ship of 56 Guns came thither, having on board M. Sweroff a Lieutenant sent by the Czarina with her Answer to His Majesty's Letter, which Sir Charles Wager has transmitted by this Messenger. The Inhabitants of Revel, by the Czarina's Order, have furnished the British Squadron with Plenty of Provisions and whatever

Necessaries they required. The Northumberland joyned the Squadron on the 23d.
