Oxford, High Street – Temporary Loading Ban

Date of Order: 5 January 2026

Coming into force: 12 January 2026

This Order is being introduced to facilitate deliveries etc. to accommodate part building demolition and subsequent reconstruction at 10-14 High Street which is anticipated to be completed January 2028. A scaffold tunnel will protect pedestrians. The effect of the Order is to temporarily suspend the loading bays at this location and to prohibit waiting. Also, the Taxi bay at the western end of this restriction will be changed to `shared use`. Loading only will be permitted for 30 minutes - 6am to 11am all days – no return within 1 hour; AND Taxis only 11am to 6am. Appropriate traffic signs will be displayed to indicate when the measures are in force. Exceptions are included for emergency service vehicles and for the purpose of the works. The Council is satisfied that it is necessary for the order and the measures to be in place until the works are completed. The relevant parts of The Oxfordshire County Council (Central Area, Oxford) (Controlled Parking Zone and Waiting Restrictions) Order 2011 (as amended) will be temporarily suspended for the duration of the works. The Oxfordshire County Council (Oxford, High Street) (Temporary Prohibition of Waiting) Order 2025 is revoked/replaced. **(Ref: T15239/AC)**

LONDON BOROUGH OF ISLINGTON THE LONDON BOROUGH OF ISLINGTON DESIGNATION OF AN AREA FOR ADDITIONAL LICENSING OF HOUSES IN MULTIPLE OCCUPATION 2025

The London Borough of Islington (“The Council”) in exercise of its powers under section 56 of the Housing Act 2004 (“the Act”) hereby designates for the additional licensing of houses in multiple occupation (“HMOs”) the area described in paragraph 4.

CITATION, COMMENCEMENT AND DURATION

1. This designation may be cited as the London Borough of Islington Designation of an Area for Additional Licensing of Houses in Multiple Occupation 2025.
2. This designation is made on 30th October 2025 and shall come into force at 12.00am on 1st February 2026.
3. This designation shall cease to have effect at 11.59pm on 31st January 2031 or earlier if the Council revokes the scheme under section 60 of the Act.

AREA TO WHICH THE DESIGNATION APPLIES

4. The Council hereby designates for additional licensing under section 56 of the Act the entire area that is the district of the London Borough of Islington, as shown in the map in Appendix A of this designation.

APPLICATION OF THE DESIGNATION

- 5) This designation applies to an HMO that,
 - a) is occupied by three or more persons;
 - b) is occupied by persons living in two or more separate households; and
 - c) meets—
 - i) the standard test under section 254(2) of the Act;
 - ii) the self-contained flat test under section 254(3) of the Act (including all purpose-built flats);
 - iii) the converted building test under section 254(4) of the Act; or
 - iv) where an HMO declaration is in force in respect of it under section 255 of the Act;
 - v) Converted building HMOs as defined by section 257 of the Housing Act 2004, but only where all accommodation units are all privately rented, and the building and accommodation units are in the same ownership. This includes buildings within mixed use developments or above non-residential premises.
6. This designation does not apply to an HMO if:
 - a) the building is of a description specified in Schedule 14 of the Act (Buildings which are not HMOs for the purposes of the Act excluding Part 1);
 - b) the HMO is subject to an Interim or Final Management Order under Part 4 of the Act;
 - c) the HMO is subject to a temporary exemption under section 62 of the Act; or
 - d) the HMO is required to be licensed under section 55(2)(a) of the Act and the Licensing of Houses in Multiple Occupation (Prescribed Description) (England) Order 2018 (mandatory HMO licensing).
 - e) Converted building HMOs, as defined by section 257 of the Housing Act 2004 that consist of no more than two flats.

EFFECT OF THE DESIGNATION

7. Subject to paragraph 6, every HMO of the description specified in paragraph 5 in the area described in paragraph 4, shall be required to be licensed under section 61 of the Act.

8. A person having control of or managing a licensable HMO must apply to the London Borough of Islington for a licence. Failure to apply for a licence is an offence under Section 72(1) Housing Act 2004. This is punishable on conviction in court by payment of an unlimited fine or alternatively they may be made subject to a financial penalty issued by the local authority, which currently can be up to £30,000. They may also be subject to additional sanctions as set out in our enforcement policies and procedures.

9. Online applications for the licensing scheme will open from 1st November 2025. To apply visit- <https://propertylicensing.islington.gov.uk/>

10. Landlords, managing agents, person managing an HMO, any tenant or other interested persons may seek general advice on this designation and to find out if their property is affected by the designation by contacting the Property Licensing Team during normal office hours, which are: 9am to 5pm, Monday to Friday. Either by email: property.licensing@islington.gov.uk or calling 020 7527 7670; or writing to London Borough Islington, Property Licensing Team, Regulatory Services, Homes and Neighbourhoods, 222 Upper Street, London N1 1XR.

11. A copy of this designation may be inspected at the London Borough Islington, Property Licensing Team, Regulatory Services, Homes and Neighbourhoods, 222 Upper Street, London N1 1XR. To arrange an appointment please contact us using the details above.

12. The Council will comply with the notification requirements contained in section 59 of the Act and shall maintain a register of all HMOs licensed under this designation, as required under section 232 of the Act.

POWER TO DESIGNATE

13. This designation satisfies the condition as defined by the Secretary of State in exercise of their powers of giving a general approval under section 58 of the Act, which is enacted in the Housing Act 2004: Licensing of Houses in Multiple Occupation and Selective Licensing of Other Residential Accommodation (England) General Approval 2024 (General Approval 2024). The London Borough of Islington has satisfied the condition by consulting with persons who are likely to be affected by it under section 56(3)(a) of the Act for not less than 10 weeks.

14. The Executive Committee of the London Borough of Islington agreed to the introduction of this designation under the General Approval 2024 and delegated the power to designate to the Corporate Director for Homes and Neighbourhoods.

It is managed by The National Archives (a non-ministerial government department) under a concessionary contract with The Stationery Office Limited ("TSO" or the "Publisher", as defined below). Any capitalised terms referred to in these terms and conditions relating to submission of notices are defined below.

By placing a Notice in The Gazette you are consenting to put official information permanently on the public record and in the public domain, online (in The Gazette website or via The Gazette mobile app), in print, and via a data service (rather than by having to search for notices on The Gazette website, customers can either create a pdf of the Notices that they are interested in, or subscribe to an electronic version of The Gazette (in full or in part) which is provided as a data service).

These terms should be read in conjunction with:

- 1 The Publisher's [privacy policy](#);
- 2 The Publisher's [policies relating to submission of notice](#); and

1 Definitions

"Authorised Scale of Charges" means the scale of charges set out at in the printed copy of the Gazette or at www.thegazette.co.uk/place-notice/pricing, as modified from time to time;

11.2 the Notice is true and accurate in all respects and does not mislead or contain potentially fraudulent information;

11.3 the Notice is submitted in good faith, does not contravene any law (statutory or otherwise), nor is it in any way illegal, defamatory or an infringement of any other party's rights or of any applicable advertising regulations, guidelines or codes of practice, nor is it subject to any court order prohibiting such publication.

12 To the extent permissible by law the Publisher excludes all warranties, conditions or other terms, whether implied by statute or otherwise, relating to the placing of any Notices.

13 The Notice Placer agrees to fully indemnify (as a debt) and hold the Publisher and The National Archives or any successor organisation, including any affiliates, officers, directors, agents, subcontractors and employees harmless from all liabilities, costs, expenses, damages and losses (including, without limitation) any direct, indirect, consequential and/or special losses and/or damage, loss of profit, loss of reputation and/or goodwill and all interest, penalties and legal costs (calculated on a full indemnity basis) and all other professional costs and/or expenses (including legal costs) suffered or incurred (including negligence) in respect of any matter

arising out of, in connection with or relating to any Notice (including, without limitation, clause 11 of the Terms and Conditions) and including (without limitation) in respect of any claim and/or demand (including threatened and/or potential claims or demands) made by any third party which may constitute a breach and/or potential breach by the Notice Placer (or their principal) of these Terms and Conditions or of any law and/or any of the rights of a third party. The Notice Placer accepts that the information contained in the Notices published in The Gazette may be used for additional purposes by the Publisher or third parties after publication as stated above and that such use may be beyond the control of The Gazette. In such instances, the Notice Placer agrees that the Publisher shall have no liability whatsoever in respect of such use by the Publisher or third parties. The Gazette will at all times act with confidentiality, discretion and adhere to any legislative requirements.

17 The Notice Placer acknowledges and agrees that the publication of any Notice is subject to any court order and/or direction of the court or such other regulatory and/or enforcement authorities including the Information Commissioner's Office, the police, the Financial Conduct Authority (and such other related regulatory organisations), the Solicitors Regulation Authority and such other authorities as may be applicable (without limitation) and that the Publisher may delay, refuse to publish or withdraw from publication if it has received evidence to that effect and may not publish such notice until it has received written evidence from the court (as the
