1. The London Borough of Hounslow hereby gives notice that on 18 February 2026 it made the above Orders under the Road Traffic Regulation Act 1984. The Orders will come into operation on 20 February 2026.

2. The general effect of these Orders will be to:

(a) make the following amendments in Park Road, Chiswick:
