

Case made and provided, though the Lord High Chancellor was pleased to indulge him with a further Time, upon his Petition and Promise to surrender himself: And whereas the said John Rogers hath been guilty of very great Frauds and Forgeries, whereby he hath cheated great Numbers of Persons of very large Sums of Money: Now in case any Person or Persons shall apprehend the said John Rogers, so that he may be brought before the said Commissioners, or the Major Part of them, such Person or Persons shall receive as a Reward of Meritius Buckle and Sparrow, Attornies, in Bread-Street, London, Two Hundred Pounds.
