HEREAS by the late Act of Uniformity, which establisheth the Liturgy, and Enacts, That no Form or Order of Common Prayers be openly used, other than what is pre-fcribed and appointed to be used in and by the faid Book; it is notwithstanding provided, that in all those Prayers, Litanies, and Collects, which do any wife relate to the King, Queen, or Royal Progeny, the Names be altered and changed, from Time to Time, and fitted to the present Occasion, according to Direction of lawful Authority: His Majefly was pleafed this Day in Council to declare his Royal Will and Pleasure, that in all the Prayers, Litanies, and Collects for the Royal Family, instead of the Words [His Royal Highness George Prince of Wales, the Princels, and their Issue, and all the Royal Family] be inserted [Our Gracious Queen Caroline, the Royal Issue, and the Rest of the Royal Family] And His Missue and the Rest of the Royal Family Missue and the Royal Family Missue Royal Family.] And His Majesty doth strict-ly Charge and Command, that no Edition of the Common Prayer be from henceforth printed, but with this Amendment; and that in the mean Time, till Copies of such Edition may be had, all Parsons, Vicars, and Curates within this Realm do (for the preventing of Mistakes) with the Pen correct and amend all such Prayers in their Church Books, according to the aforegoing Direction: And for the better Notice hereof, that this Order be forthwith printed and published, and sent to the several Parishes; and that the Right Re-verend the Bishops do take Care that Obe-dience be paid to the same accordingly.

That the said Parliament Will and Pleasure, That the said Parliament shill and Piedjure, I hat the faid Parliament shall, on Tuesday the Twenty Seventh Day of this Instant June, be held, and Sit for the Dispatch of divers Weighty and Important Affairs; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners of Shires and Burghs of the House of Commons, are hereby required and tommanded to give their Attendance arrowingly at Wostminster, on Tuesday. ## A PROCLAMATION,

Requiring all Persons, being in Office of Authority or Government at the Decease of the late King, to proceed in the Execution of their respective Offices.

GEORGE R.
WHereas by an Ast made in the Sixth Year of the Reign of Her late Majesty Queen Anne, entituled, An Act for the Security of Her Majesty's Person and Government, and of the Succession to the Crown of Great Britain in the Protestant Line, it was Enacted, That no Office, Place, or Employment, Civil or Military, within the King-dems of Great Britain or Ireland, Dominien of Wales, Town of Berwick upon Tweed, Ites of ferfey, Guernsey, Alderney, and Sark, or any of Her Majesty's Plantations, should become veid by Reason of the Demise of her said late Majesty, her Heirs or Successors, Kings or Queens of this Realm; but that every Person and Persons in any of the Offices, Plices, and Employments aforefaid, should continue in their respective Offices, Places, and Employments, for the Space of fix Months next after such Death or Demise, unless sometiment of the space of fix Months former removed and discharged by the next Successor, to rehom the Imperial Crown of this Successor, to rehom the Imperial Crown of this Successor, to rehom the Imperial Crown of this Successor, and their Coaches, Chariots or Chairs. His Majesty is pleased to permit this Military Officers to appear before him in Realm was limited and appointed to go, remain, and d'scend; and that all Officers in ary Offices, Places, or Employments, who should be by that Act continued, should take the Oaths therein mentioned, and do all other A ts requisite by the Laws and Statutes of this Realm, to qualify themselves to be and continue in such their respective Places, Offices and Employments, within such Time, and in such Manner, and under such Pains, Penalties, and Disabilities, as they should crought to do, had they been newly elected, appointed, constituted, and put into such Offices, Places, or Employments, in the usual and ordinary Way: We therefore, with the Advice of Our Privy Council, declare Our Royal Will and Pleasure to be, and do hereby direct and command, That all Persons, who, at the Time of the Demise of our late Royal Father, of Glerious Memory, were duly and lawfully possessed of, or invested in any office, Place, or Employment, Civil or Military stithin Our Kingdom of Great Pritain or ry, within Our Kingdom of Great Britain or Ireland, Dominion of Wales, Town of Berwick upon Tweed, Isles of Fersey, Guernsey, Alderney, or Sark, or any of Our Plantations, do, with the first Opportunity, take the respective Oaths of Office, and all other Oaths, as required by the said Act, and in the mean time do not fail every one severally, according to his Place, Office, or Charge, to proceed in the Performance and Execution of all Duties belonging to their respective Offices. And We do hereby require and command all Our Subjects to be aiding, helping, and affifting, at the Commandment of the faid Officers and Ministers, in the Performance and Execution

of their respective Offices and Places, as they and every of them tender O:r utmost Displeasure, and will answer the contrary at their Perils.
