Hanover, August 2, N. S.

ON Friday last, the 29th of July, about Nine in the Morning, the King set out from Osterode, and arrived at Three in the Afternoon at Munden, where He was received with the greatest Demonstrations of Joy. His Majesty reviewed that Day a Regiment of Foot of His own Troops, which was quartered there; and the same Afternoon Prince William and Prince George of Hesse, with Brigadier Sutton and General Diemar, waited on His Majesty with an Account of the Dispositions that were made for His Majesty's reviewing the Hessian Troops in His Pay. On Saturday the 30th the King went from Munden at Eight in the Morning, and was met on the Road about Nine by his most Serene Highness the Landgrave of Hesse, at the Place appointed for His Majesty's leaving His Coach and getting on Horseback: After the Ceremony of their Meeting was over, His Majesty advanced towards the Right Wing of the Army, which was drawn out in one Line of Battle at the Head of their Camp, on a Plain near Cassel: When His Majesty arrived at a certain Distance from the Line, a Signal was given by Rockets for a triple Discharge of the Artillery in the Camp, and from the Ramparts of the Town, which ended exactly as His Majesty came upon the Right Wing of the Line; where the King was received by Prince William, and the General Officers of that Wing, at the Head of the King of Sweden's Regiment of Dragoons. His Majesty passed along the Line, being saluted in the usual manner; after which His Majesty went to a magnificent Tent, pitched for that Purpose in the Centre of the Line, where the Princess of Hesse, and a great Number of Ladies who were there, had the Honour of being presented to His Majesty: The Troops then marched off from the Right, and passed by His Majesty, the Horse and Dragoons by Fours, consisting of Twenty Squadrons, and the Foot by Sub-Divisions, consisting of Eleven Battalions, and they being returned to their Ground, His Majesty was pleased to see the Foot perform their

Exercise, which they began upon the Signal given by one Cannon, and went through the whole without any further Signals or Word of Command; other Signals being then given for their Firings, they went through the whole with such Readiness, Order and Exactness, as gave His Majesty entire Satisfaction; then His Majesty got on Horseback again, and having passed a second Time along the Line to a Bridge of Boats laid over the River for that Purpose, went to the Orangerie in the Suburbs of Cassel, where His Majesty and His whole Company were splendidly entertained at Dinner by his Highness. About Eight a-Clock in the Evening His Majesty left that Place on His Return to Munden, under a triple Salvo of all the Cannon from the Ramparts and the Camp, each of which was followed by a *Feu de Joye*, of the whole Army, drawn up again for that Purpose. The Landgrave and Prince William accompanied the King Part of His Way to Munden, where His Majesty arrived at Ten that Night, and rested there on Sunday the 31st. Yesterday the King went from Munden to Neuen-Over, to see His Studd of Horses, and lay last Night at Rotherkirchen, and this Afternoon His Majesty returned to Herrenhausen in perfect Health. The Lord Townshend and Lord Waldegrave, came back this Evening to Hanover, as did also Count Kinski and several other foreign Ministers. On the 30th of July in the Evening M. Chavigni arrived from Ratisbon, being sent hither by his most Christian Majesty, to negotiate his Affairs at this Court.

Hanover, Aug. 5, N. S. On Tuesday last, the 2d Instant in the Evening, General Diemar Minister from Hesse, M. Hopp Envoy Extraordinary from the States General, and Cyrill Wich, Esq; His Britannick Majesty's Envoy Extraordinary to the Hanse-Towns, returned hither from Cassel. On Wednesday the 3d in the Afternoon arrived here from France, but last from Holland, the Hon. Robert Trevor, Esq; one of the Sons of the Lord Privy Seal; at the same Time the Lord Cardrols, Son of the Earl of Buchan, returned from Cassel; and in the Evening a Play was acted upon the Theatre in

in Herrenhausen Gardens for the Entertainment of His Majesty. On Sunday next, the 7th Instant, the Court will go into Mourning on Occasion of the Deaths of Prince Charles of Denmark and the Prince of Sultzbach, and about the latter End of the next Week the King intends to begin his Progress to Kouy, Stade, and Harburg, and afterwards to come to Lunenbourg, where His Majesty is to review a Body of His Troops, consisting of about 8000 Men, which are to be drawn together for that Purpose. 'Tis thought His Majesty will go from thence to Ghorde for a few Days, and then return to Hanover, taking Zell in His Way. M. Dankelman, one of the Aulick Councillours, is come hither from Vienna upon his private Affairs. Yesterday arrived here the Lord Boyne, of the Kingdom of Ireland, in Company with Edward Walpole, Esq; from Geneva, but last from Cassel, where they had been to see the Review of the Hessian Troops.
