The Rt. Hon. the Lords of the Treasury having appointed Money for paying of Half Pay to Sea Officers from the 1st of July 1729, to the 31st of December last, according to His late Majesty's Establishment on that Behalf; these are to give Notice, That the said Payments will begin to be made at the Treasurer of the Navy's Office in Broad-Street, at Nine of the Clock in the Morning of the following Days, viz.
