ON the 13th Instant the Council of State in a Body presented to the States General the Estimate and Establishment of the Number of Forces to be kept up for the Year ensuing, being the same as for the last Year, and it is sent to the respective Provinces for their Approbation. It is said six Men of War are to be fitted out to be commanded by Commodore Schryver. Sir Cyril Wich, Bart. His Britannick Majesty's Envoy at Hambourg, is arrived here from thence, and proposes to embark next Week for England.
