Moscow, May 24, O. S.

COUNT Pototzky arrived here the 20th Instant, and had Yesterday his first Audience of her Czarish Majesty as Envoy Extraordinary of the King and Republick of Poland. Lieutenant General Romanoff, one of the Senators, Lieutenant Colonel of the Preobrazensky Guards, and Knight of St. Alexander, who was formerly Ambassadour at Constantinople, and not long since commanded in Persia, is in Disgrace.

Stockholm, June 16, O. S. The States have been assembled all this Week, Morning and Afternoon, to dispatch the most material Affairs; others of less Importance will be remitted to the King and Senate; both the one and the other relate only to Domestic Affairs. To-morrow the Separation of the Diet will be proclaimed for next Saturday, Friday being a great Festival here. The Senators Langerberg, Stromfelt, Tornflycht, Barck, Hard, Cronstedt, and Creutz, were Yesterday made Counts; all the other Senators were so before. M. von Kochen, Major General Lowen, Budenbrock, Furstemberg, and Rosen, were made Barons. The Dutchess of Mecklenbourg is expected here soon; her Highness's Arrival will determine the Day of the King of Sweden's Departure, his Majesty proposing at present the 28th or 30th Instant; but it is not yet resolved where his Majesty will land; and a Secret will be made of the Place, to avoid Invitations and Ceremony.

Copenhagen, June 30, N. S. The King of Denmark set out for Holstein on the 28th Instant, with the Queen, and two Princesses, his Aunt and his Sister. The High Chamberlain, M. Blome, General Lewennoern, and M. von Hagen, are gone along with the Court. Their Excellencies Mess. Plessen and Ronsenkrauts remain here. The Jour-

ney, according to the present Regulation of it, should conclude in 22 Days.

And they are hereby ordered to give Notice of this Order, by affixing Copies thereof in the most publick Places within the said City, that no Person may pretend Ignorance.
