R. Ward, one of His Majesty's Messengers, arrived here the 29th past, being sent by Mr. Colman, His Majesty's Minister Plenipotentiary at Parma, with an Account, That a Convention had been signed at Florence between the Spanish Minister there, and those of the Great Duke of Tuscany, for settling the Family Concerns between the King of Spain and his Highness, and his Sister the Electoress Dowager Palatine, with Respect to the immediate Succession of the Insante Don Carlos to that Dutchy; and that as a Mark of their particular Regard for his Royal Highness, the Great Duke and the Electoress had invited him to come and reside at Florence as presumptive Heir to that State.

The next Day another of His Majesty's Messengers arrived with Letters from Mr. Keene, His Majesty's Minister Plenipotentiary at the Court of Spain, of the 26th of last Month, N. S. with an Account, that Orders were given for fitting out with all Expedition the Squadron of his Catholick Majesty's Ships that was to attend the Introduction of the Spanish Garrisons, and that the General Officers and the Regiments were named for that

Purpose.

Mr. Keene adds, that the most precise and positive Orders had been sent by several Advice Boats to the West Indies, for preventing the unlawful Proceedings of the Guarda Costas and other Spanish Ships in those Parts, which were again to be repeated by the Officer who is to command the Azogue Ships that would shortly sail thither; and that the Governours of St. Domingo and Porto Rico, who have been most remarkable for countenancing and encouraging the Depredations upon the Subjects of Great Britain trading in those Parts, had been divested of their Employments, and were sent for Home, to answer for the several Misdemeanours which were laid to their Charge.
