**T**HIS Morning the Commissaries respectively appointed by their Britannick and Catholick Majesties to treat concerning such Matters as are referred by the Treaty of Seville to their Examination, Discussion, and Decision, met in an Apartment prepared for their Conferences in the Contractation House; their respective Full Powers were produced and read, and Copies of them exchanged. The Spanish Commissaries received those of his Britannick Majesty with great Civility, and gave them all imaginable Assurances of his Catholick Majesty's sincere Intentions, as well as of their own Inclinations to bring the Affair of their Commission to a speedy and happy Issue. They adjourned to Monday the 3d of March, next, N. S. and agreed from that Time forward to meet every Monday and Thursday.

*Hambourg, March 1, N. S.* The Bishop of Lubeck, who has been dangerously ill of the Small Pox, is (according to the Opinion of his Physicians) out of Danger, and in a fair way of Recovery. His Highness's Sister, Princess Anne, is perfectly recovered. This Evening or To-morrow Prince Maximilian of Hesse is expected here on his Return from Stockholm to Cassel.

*Berlin, March 4, N. S.* The Prince of Valachie, who is going with the Character of
