THIS Court has received Advice, that Tachmach Culican had beaten the Turks in Persia, and had laid Siege to Babylon with an Army of Last Sunday her Czarish Ma-Topoco Men. jesty was pleased to make Count Gallowin, who was in Sweden, President of the Admiralty, Baron Schaffiroff President of the College of Commerce, and Prince Cherbatoff Vice Prelident of the same. Her Majesty has given Orders for the marching of a Body of Troops to the Frontiers of Poland the 15th of next Month, and has named most of the General Officers that are to command them. Berlin, April 21, N. S. Prince Leopold of Deilau has been ordered to hold himfelf and his Regiment in Readiness to march to Mulhausen. The King of Prussia has caused Assurances to be given to the Dutch Factors at Konigsberg, that what had happened about the Loan desired of them for the Settlement of the Saltzburgers, was done by Mistake; and that far from having the least Intentions to do any Thing that could be burtful to their Trade, he was ready to enlarge their Privileges and Immunities. M. Munchausen, the Duke of Wolfenbuttel's first Minister, arrived here this Morning in his Way to Vienna. The Marquess de la Chetardie, Minister from the French King, has had Conferences with the Ministers for foreign Affairs, upon.a Declaration he made to them some Time ago in Relation to the Affairs of Poland. The Court is at Potzdam, and the King takes the Diversion of Stag Hunting twice a Week. The last Letters from Dresden advise, that the Court was gone from thence to Leipsick, and that the Count de Castel was appointed Governour of Dres-
