Hague, Sept. 6, N. S. Letters from Heidelberg of the 30th past advise, that Prince Eugene arrived there the 27th, and fixed his Head Quarters at that Place. On the 29th the Russian Troops being all arrived, were reviewed by his Highness, and performed their Exercise to his entire Satisfaction. The Imperial Troops, which lay at Bruchsal, were almost all come into the Camp marked out for them near Heidelberg; and the Duke of Arenberg, with Part of the Troops of the Circles, had taken Possession of the Camp of Bruchsal. In the mean Time the main Body of the French Army, commanded by the Marquess de Coigny, had encamped between Oppenheim and Worms; and the Count de Bellisse lay with the Body of Troops he commands between two and three Leagues of Oppenheim.
