**T**HE Princess Royal and the Prince of Orange, having taken their Leaves of his Britannick Majesty at Utrecht, went back to Loo, whence they are expected here in about a Fortnight, in order to pass some Weeks at this Place. The Count de Montijo proposes to set out from hence on the 12th Instant for Paris. M. d'Osorio, and M. d'Alsevedo, will proceed from hence for London by the next Packet-Boat. The Prussian Minister has newly presented a Memorial to the States, requiring Copies of the Writings which relate to the Inheritance of Orange, which has been granted. His Excellency Mr. Walpole causes great Preparations to be made for celebrating next Thursday the Birth Day of the King his Master; when a great Number of Persons are invited to dine with him.

Floor and Shop Door: Her Majesty, for the better discovering and bringing to Justice the Person or Persons concerned in the said Crimes, is pleased to promise her most gracious Pardon to any one of them, who shall discover his or her Accomplice or Accomplices in either of the said Crimes, so as they, or any of them, may be apprehended and convicted thereof.

And as a further Encouragement, the said John Kerr doth hereby promise a Reward of Ten Pounds to any Person or Persons, who shall discover the Person or Persons who sent the said Letters: And the said Nicholas Read doth also hereby promise a Reward of Twenty Pounds to any Person or Persons who shall discover the Person or Persons who attempted to burn his House: The said respective Sums to be paid by them upon the Conviction of the said Offenders, or any of them.
