OME Days ago this Court received from Felt Marshal Lacy the Particulars of the Surrender of Asoph; and among other Things, that the Turkish Garrison, which at first consisted of about 6000 Men, was at last reduced to less than 3000, among which were 1700 Janislaries. They were permitted to go into the Territories of the Cuban Tartars; but before they less Asoph, they took an Oath not to bear Arms against the Czarina for a Year. About 480 Russians were killed during the Siege, and between 7 and 800 wounded; which is very few, considering the Importance of that Place to Russia. M. Poninsky, the Son of the Mar-shal of the General Consederation, arrived here the 12th Instant from Warsaw, with the agreeable News, that the Diet was happily ended. This Court is very much rejoyced, that the Diet has consented that the Courlanders shall be at Liberty to chuse another Duke after the Decease of the present, which they could hardly have expected without some disagreeable Limitations; for it was proposed in the Diet by some, that though Courland should not be incorporated to Poland, the Republick should name a Successor to the present Duke. All the other Assairs depending between this Court and that of Poland, are to be ended by the Republick's Deputies, and M. Keyserling the Russian Minister. King Augustus having promised that 40 Days after the Diet was ended, all the Saxon and Russian Troops should march out of Poland, Orders are already fent by this Court to Lieutenant General Keith, to return to Russia with those under his Command. As this is the first Diet that has subsisted since the Year 1727, it is now hoped a perfect Tranquillity

will be foon fettled in that Country. The Czarina is now at Peterhoff, about 28 Miles from hence, where her Majesty designs to reside about a Month.

Warsaw, Aug. 1, N. S. The Prusham Resident here has acquainted M. Bruhl, by Order of the King his Master, of that Prince's Design of making a Recognition and Acknowledgement of King Augustus; and at the same Time gave Assurances of the sincere Desire of his Prusham Majesty to cultivate a good Friendship and Correspondence with this Court. M. Melsinski, Castelanitz of Rypin, having insulted the Bishop of Posen at the King's Table while they were celebrating the Czarina's Name-day, is condemned to three Months Imprisonment, and asterwards to ask Pardon in form of the King and of the Bishop. At Three a-Clock this Morning the King and Queen set out for Dresden, where they hope to arrive in about nine Days.

Stockholm, July 23. His Swedish Majesty went on Tuesday last a Hunting to a Place called Wyksberg, three Swedish Miles from hence: The Saxon Minister, and the Chamberlain Loserare, were of the Party; the latter of those Gentlemen is to set out on Monday next from hence for Dresden, and designs to pass thro' Hanover and Cassel in his Way thither. His Swedish Majesty, after having killed sour Elks at Wyksberg, returned Yesterday to Carlberg.
