Warsaw, August 18, N. S.

THERE has been little remarkable stirring in these Parts since the King's departure for Saxony, almost all the Nobility having retired to their Country Seats. The Russian and Danish Ministers followed the Court to Dresden. There remain now in this Country only 1200 Men of the Saxon Troops, which are commanded by Major General Klingenberg. The Primate has been dangerously ill, but is something better at present. Prince Czartowinski, the Vice Chancellor of Lithuania, set out from hence a few Days since for Dantzick.

Berlin, Aug. 14, N. S. To-morrow being the King of Prussia's Birth-Day, his Majesty removed this Morning from hence to Potzdam; as he does every Year, to avoid receiving the Compliments usual on such Occasions. M. Brackel, the Minister from Russia at this Court, received this Morning Letters from Petersbourg of the 20th of July O. S. advising, that an Express was just arrived there from Felt Marshal Munich, with the News that on the 17th of June last, he had made himself Master of Bacciefaray, the Capital of the Crimea, where the Cham usually resided; and that on the 22d of the same Month, the Town called Saltawfaray, or Achmet's Town, the Residence of the Vice-Cham, had in like Manner surrendered to that General.

His Majesty having been graciously pleased by his Warrant under his Royal Sign Manual, dated the 10th of June, 1733, to establish certain Rules and Orders for the better Government of the Charity for the Relief of poor Widows of Commission and Warrant Officers of the Royal Navy: These are to give Notice to all such Widows, whose Husbands died on

And the Court of Assistants do hereby give Notice, that they shall meet at this Office on Tuesday the 14th of September, at Eight of the Clock in the Morning, in order to receive and adjust the Claims of all such Widows as shall be qualified according to the said Rules and Orders.
