His Majesty in his great Wisdom thinks it affords a melancholly Prospect, to consider to what Height these audacious Practices may rise, if not timely suppressed; and that it deserves no small Attention, that they may go on to affect private Persons in the quiet Enjoyment of their Property, as well as the general Peace and good Order of the Whole. His Majesty apprehends it to be unnecessary to enlarge upon a Subject of this Nature, and therefore hath commanded us barely to mention it to you, who, by the constant Tenor of your Conduct, have shewn, that you consider the Support of his Authority and the Security of his Government, as inseparable from the Preservation of the publick Tranquility, and your own Safety.
