His Majesty apprehends it to be unnecessary to enlarge upon a Subject of this Nature, and therefore hath commanded us barely to mention it to you, who, by the constant Tenor of your Conduct, have shewn, that you confider the Support of his Authority and the Security of his Government, as inseparable from the Preservation of the publick Tranquility, and your own Safety.
