Naples, Dec. 2, N. S. The King has ordered some Companies to be drawn out of three Regiments of Foot in order to compose a fourth Regiment, the Command of which his Majesty has given to M. Galca, one of the Gentlemen of his Bed-chamber. The Regiment Royal Macedonia of Foot, being now compleat, is ordered to march hence to Capua.

Rome, Dec. 6. On the 29th the Prince Electoral of Saxony, attended by the Princess Albani, was to visit the Corsini Family, by whom his Highness was received and complimented with great Formality. His Electoral Highness often entertains the Roman Nobility with Dinners, &c. and employs his Time otherwise in observing the Antiquities of this City. On the 2d the French Ambassadour returned from Frascati, and immediately sent his Secretary to compliment the Prince Electoral of Saxony.

Bol gna, Dec. 13. Orders from the Court of Vienna have been sent to the Governor of Mantua, to prepare the Necessaries in that City for the Reception of the Grand Duke, the Grand Dutchess and Prince Charles of Lorraine, on their Passage through that Place for Tuscany.
