Naples, April 7, N. S.

HE King has ordered the ex-changing of the Garrisons both of this Kingdom and that of Sicily, on a Discovery of a Mutiny designed by a Party of Soldiers of the Regiment d'En-ho, who together with some Prisoners proposed to desert from Gaeta.

Bologna, April 13. Some few Days ago the Regiment of Foot lately railed by the Duke of Modena, confishing of 1700 Men, arrived at Mantua on their March to Germany. The Duke of Modena is raising 700 Men more, who are to be distributed in the Fortresles of his Dominious. On the 11th, a Battallion of the Imperial Regiment Pallawicini from Tulcany, embark'd at Goro in

their Passage cross the Gulph of Venice to Trieste for Hungary.

Florence, April 13. On the 6th in the Evening M. Passonei arrived here from Rome. On the 8th he had a private Audience of the Great Duke and Dutchess, in which he return'd the Compliment to their Highnesses on the Part of the Pope, and on the 12th presented the Golden Rose sent to her Royal Highness by the Pope. This Function was performed publickly at Court in a large Room purposely fitted out as a Chapel, where the Archbishop and Clergy assisted, and the Ministers and Nobility were present. The Grand Duke and Dutchess afterwards dined in Publick. M. Spinola is shortly expected from the Republick of Genoa. On the 9th Sir John Shadwell and his Family arrived here. On the 10th the Baggage of Prince Charles of Lorrain set out for Germany. The Departure of Part of the Court hence on its Return to Vienna, is fix'd to the 21st Instant. The Great Duke and Prince Charles are to embark at Lerici for Genoa, thence to Turin, to visit the Queen of Sardinia; and the Great Dutchess is to set out hence three or four Days afterwards by way of Bologna for Milan, where her Highness will wait the Arrival of the Great Duke, in order to proceed together to Switzerland to meet the Dutchess Dowager of Lorrain. On the 11th the Great Duke review'd the second Bat-talfion of his Regiment of Lorrain Foot-Guards, who, 'tis said, are to proceed to Leghorn to reinsorce that of Pallavicini,

marched for Hungary.

Florence, April 20. On the 13th, the Great Duke, Dutchess, and Prince Charles of Lorrain, were to see the Villa of Pratolino, and on the 10th that of Castello and Petraia; so that their Royal Highnesses have seen all their Villas and Country Seats in

and about this City. Their Royal Highnesses have regularly been to visit the Electress Dowager Palatin during her Indisposition, of which her Electoral Highness is almost recovered. On the 14th a Courier was difpatched by the Great Duke to Nancy to the Dutchess Dowager of Lorrain, 'tis said, to appoint the Time and Place of their Meeting in Switzerland. On the 17th the Marquess Fogliani arrived here, to return the Compliment to the Grand Duke and Dutchess on the Part of the King of Naples, and on the 16th he had accordingly a private Audience of their Royal Highnesses.
