Letters which are just come in from Vienna, have brought us the News, that a definitive Treaty of Peace between the Czarina and the Turks, as well as that of the Emperor, had been figned in the Ottoman Camp before Belgrade on the 18th of last Month. The King of Prussia being come to Town on Tuesday Evening last, the next Morning between Eight and Nine M. Pudeweltz came to the Marquess de la Chetardie's Lodgings, and having taken him in his Coach, conducted his Excellency to his Audience.
