An ACI for granting and continuing to his Majefty an additional Duty on Beer, Ale, Strong Waters, Wine, Tobacco, and other

Goods and Merchandizes therein mentioned. An Act for granting to his Majesty a fur-ther additional Duty on Wine, Silk, Hops, China, Earthen, Japaned or Lacquered Ware, and Vinegar; and also a Tax of Four Shil-lings in the Pound on all Salaries, Profits of Employments, Fees and Penfions, to be appli-ed to pay an Interest of Five Pounds per Cent. per Ann. for the Sum of Three Hun-dred Thousand Pounds, or such part thereof as shall remain unpaid on the 25th Day of December, 1739; and towards the Discharge of the faid principal Sum.

At the prefenting of which Bills, the Speaker of the Houfe of Commons made the following Speech to the Lord Lieutenant.

May it please your Grace,

I Obey with great Satisfaction the Commands of the Houle of Commons, by prefenting to your Grace the Bills for granting fuch Supplies, as were asked with great Mo-deration from the Throne, and given with equal Unanimity by the Subject.
