Cardinal Acquaviva, before the Pope's Death, had solicited and obtained, in Favour of the King of Spain, an Indulto for the levying of Ten per Cent. for five Years successively on the Ecclesiasticks in India, in Consideration of the present War. M. Errigues, in Consequence of the Approbation he had received from the Ministers of State in regard to the Affair of San Marino, has restored the former Liberty to that Republick. As yet Things continue here very quiet. Cardinal Corsini, to gain the Affection of the low Sort of People, has caused large Sums of Money to be distributed among them.

Copenhagen, Feb. 23. The Cold is grown much more severe of late, and as the Easterly Winds, at the Beginning of the Winter, unhappily prevented the Arrival of Ships with Wood from Holstein and Jutland, People could not make their usual Provision; therefore the Town is actually in great Want of Fuel. The Merchants having now none to dispose of, the King has been pleased to order some supernumerary Stores of his own to be sold at a moderate Price, and it is equally distributed to the Purchasers in certain small Portions, by Virtue of a Certificate from the Magistrates; such a Scarcity there is already in this Article, which must daily increase as the Frost holds.

Dresden, March 2. Count Wratisslaw, the Emperor's Ambassadour at this Court, return'd the 29th last past: He has been absent some Months on his private Affairs.

Hambourg, March 4. General Lewenorhn died at Copenhagen on the 27th past of a painful Disease, at the Time when the Physicians conceived some Hopes of his Recovery. It is generally believed that he will be succeeded in his Place of Secretary at War either by General Schulenburg, Lieutenant General Pretorius, or Major General Larch; but several are of Opinion that the latter will carry it.
