**O**N the 24th sixteen Waggons with four large Brass Cannon for Battery, Ammunition and Military Stores, and many Gun-Carriages were brought from the Fortrefs of Capua to this Arsenal, the Place of Rendezvous for all the Stores.

*Legborne, Feb. 10.* A few Days ago anchored at this Port a Dutch Ship laden with Provisions for the Dutch Squadron which is shortly expected on this Coast; for which the Dutch Consul has obtained Leave of the Regency.

*Berlin, Feb. 28.* On the 19th Instant his Prussian Majesty set out from hence, arrived at Crossen that Night, the next Day proceeded for Silesia, and the 21st arrived at Schweidnitz, where he has settled the Head Quarters for his Forces in Silesia: Before his Departure from hence his Majesty went to Potzdam, and was present at the Ceremony of giving new Colours to his own Regiment, which he has created Guards. His Life-Guards appeared at the same Time at Potzdam, took the Oaths, and had their Standard delivered to them. This Regiment and Troop of Guards are on their March for Silesia. Several Vessels laden with Artillery for Battery and other Pieces of Cannon, and large Stores of Ammunition, went from hence Yesterday for the Service of the Army in Silesia, which 'tis said will be ready to open the Campaign the Middle of next Month.
