WHereas his Majesty has signified unto us
his Royal Pleasure, that the Parliament
of this Kingdom, which now stands prorogued
to Thursday the Ninth Day of April
Instant, be further prorogued to Tuesday the
Twenty Fifth Day of August next; we do
therefore publish and declare, that the said
Parliament be, and accordingly the said Par-
liament is, hereby further prorogued to Tues-
day the Twenty Fifth Day of August next:
Whereof the Lords Spiritual and Temporal,
and the Commons in this present Parliament,
are to take Notice accordingly.

Berlin, April 15, N. S. On Thursday
last arrived here an Officer from Silesia, pre-
ceded by five Postillions: This Officer had
been dispatch'd by the King of Prussia to give
the two Queens an Account in general, and
by Word of Mouth, that on the 10th Instant
there had been an Action between the Prus-
sians and the Austrians, in which his Prussian
Majesty had been victorious; and that ano-
ther Express should soon follow with the
Particulars. Accordingly the next Day at
Noon arrived here another Officer, preceded
by 16 Postillions, who brought the following

Account. That the Austrian Army under the
Command of Felt-Marshal Count Neiperg
was advanced into Silesia; and his Prussian
Majesty being informed they were marching
directly towards him, he immediately drew
together all the Troops he could; and made
the necessary Dispositions for a Battle. That
on Monday the 10th Instant the two Armies
met and engaged at a Place called Molwitz or
Mogwitz, about a League on this Side Neifs.
That the Fight began at Two o'Clock in the
Afternoon, and lasted till Six in the Evening,
when the Austrians thought proper to retire
in very good Order under the Cannon of Neifs;
leaving the Field of Battle to the Prussians:
That the Action was sharp, and bloody on both
Sides; that in the beginning the Austrians drove
back the left Wing of the Prussians, at which
Lieutenant General Count Schulenburg
commanded, who had the Misfortune to be
killed at the first Onset; but that this Con-
fusion was soon after redressed by the Gren-
adiers which his Prussian Majesty had inter-
mixed with the Horse; such a Disposition
being thought necessary upon the Informati-
on his Prussian Majesty had received that the
Austrians were superior to him in Cavalry.
The Attatek on the Prussians Right Wing
was as warm as that on the Left, Five Squa-
drons of Schulenburg's Dragoons having
been almost all destroyed. The Regiment
of Carabineers of Count Wartensleben suf-
fered also very much, as did the first Bat-
talion of Guards, who had 16 Officers killed
or wounded out of 25. The whole Loss of
the Austrians, according to the Accounts the
two Queens have, is 4000 killed, wounded
or Prisoners; and they make that of the Prus-
sian Army to be 600 killed; and 1200
wounded.

List of the General and other Principal Officers killed and wounded on the Side of the Prussians in the Action near Molwitz or Mogwitz in Silesia on the 10th of April. Lieutenant-General Count Schulenburg; the Margrave Fiederick of Brandenburg, Colonel, and also Colonel of a Regiment in the Dutch Service; Colonel Bork of the Regiment of Gravenitz; Lieutenant-Colonel Fitzgerald of a Regiment of Guards; the Majors Knobelsdorf and Schenkendorf; M. Mulendorf, one of his Majesty's Pages; and the Master of the King's Household, Killed. M. Meaupertui, an eminent Mathematician, missing. Felt-Marshal Schwerin; the Lieutenants-General Marcwitz and Kleist; Major-General Margrave Charles; the Colonels Prince William, Brother to the Margrave; Wartensleben of the Carabineers; Rochau; and Finck, the King's Aide de Camp; and Major Bork, wounded. Generals of the Austrians killed and wounded: General Lentulus, and the Prince of Birkenfeld, killed. Felt-Marshal Count Neiperg, wounded in the Hand, and General Brown and General Grun were also wounded.

and Facts were done and committed in the Hollow Way near to the Road Post on Gillingmoor, in the Hundred of Rydale, within the County of York aforesaid.
