Naples, February 27.

N the 6th the Duke di Castropignano fet out from hence for the Ecclesiastical State, to take upon him the Command of the King's Troops. Duke Ssorza Cesariné, after having taken Place and covered before the King, as Grandee of Spain, set out from hence on his Return to Rome. The Court has fixed its Departure hence for the Villa of Portici to the 2d of March. Last Week the King made a Promotion of General Officers, amongst whom Don Nicholas de Sangro has been appointed Captain General of his Forces in this Kingdom, in the room of the Duke di Castropignano, who commands the Army in the Ecclefiastical State. The Convoy of 24 Transports, escorted by the Ships of War St. Phillip and Parthenope, failed from Messina on the 13th Instant, on their Voyage to the Adriatick Sea, there to land the Artillery, Ammunition and Military Stores for the Expedition to Lombardy.

Rome, March 3. On the 10th of last Month, a Wooden Bridge was ordered to be built over the Tiber at Monte Rotondo, for the Passage of four Companies of Gunners from Naples and Gaeta, one Hundred of which on the 14th passed near the Walls of this City on their March to join the Neapolitan and Spanish Army. Baron Scarlatti, the Bavarian Minister, has presented to the Pope a Letter of Notification from his Master, of his Election to the Imperial Throne. On the 23d the Baron received his Credentials as Envoy Extraordinary, and accordingly had an Audience of the Pope, and has put over the Door of his Palace, the Arms of the new Emperor. M. Thun has demanded of the Pope, the Passage through the Ecclesiastical State for a Body of 25000 Auftrian Troops, but from what Part they are expected is not as yet known. A Party of 30 Austrian Husiars has made an Incursion as far as Faenza, to discover the Motions of the Spaniards, who are keeping themselves in Guard to prevent a Surprize. The Spanish and Neapoli-tan Troops continue their March very slowly through this State; the greatest Part of them are at Pesaro, which it seems they design as a Place of Arms. A Tumult has lately happened at Spoleti, between the Inhabitants and the Spaniards on Account of Deserters, which the latter pretend the Inhabitants had affisted, in which 24 Spaniards and some of the Inhabitants were_killed. An Edict was lately published on the Part of the Government, imposing heavy Penalties on fuch Persons as shall talk disrespectfully of the Powers at War. On the 21st died Cardinal Coiro, by which the Fourteenth Cardinal's Hat is become vacant. M. Thun, the Queen of Hungary's Minister, has lately presented a Memorial to the Secretary of State, to prevent the Acknowledgement of the new Emperor: The Pope has, notwithstanding, in a Consistory

which he held on the 28th past, acknowledged that Prince, and caused the usual Functions on such an Occasion to be performed; on which the Palaces of the Cardinals, Ministers and Roman Barons were illuminated for two Evenings fuccessively, those of Cardinal del Giudice, M. Thun, M. Franchini, Prince of Santa Croce, and Bracciano excepted. It is confirm'd, that Cardinal Borghese is to have the Protectorship of the Empire, in which case Prince Borghese will accept the Embassy of the Empire. Spanish Troops are advanced no farther than Rimini, whither the Artillery from Naples was to be transported from Ancona, and as the Spanish Engineers had measured the Walls of that Place, and observed the Country about it, it is thought, that they design to remain there for some Time.

Turin, March 7, N. S. The Preparations for the Campaign are carrying on with the utmost Diligence. The King of Sardinia's Troops, to the Number of 22 Battallions and 18 Squadrons of Horse, were ordered to begin their March as Yesterday, and to advance into the Pavesan, the Plairantine, and the Dutchy of larma, with the necessary Train of Field Artillery, Ammunition, and Stores, where they are to be posted in such a Manner as to be united in a Body in twice 24 Hours if requifite, in order to march to the Enemy, and back the Hungar an Troops in the Modenese. The General Officers are all named, and are already fet out, or on the Point of fetting out for the Army; and it is not questioned but between the 15th and 20th Instant the King of Sardinia will leave Turin, and put himself at the Head of his Troops. Yesder Prince Mansfelt passed through this Town in his Way to Rome, whither he is going with the Character of the Emperor's Ambassador to the Pope.

Florence, March 11. In Consequence of the Orders sent by M. de Montemar to the Marquess de Castellar, to change the Rout, and to proceed by Valdarno to Arezzo, Borgo, St. Sepolero, &c. into the Romagna, instead of going to Bologna (as it was stipulated at Pesaro between M. de Montemar and M. Velluti, the Tuscan Commissary) in order to join those under his Command, and the Neapolitan Troops by a shorter Passage through Furlo and Urbino in the Ecclesiastical State, on the 5th Instant, the said Column passed under the Walls of Florence, as did on the 7th the fecond, and on the 9th the third Column, all Foot, conducting each of them their Field Baggage, their small Brass Field Cannon, and a fuitable Quantity of Ammunition and military Stores, and were followed this Day by the fourth Column, amounting hitherto in all to about 11000. They have paid in ready Money for the Provisions and other Necessaries they have had Occasion for, and observed hitherto a good Discipline: Many of the Nobility and Inhabitants of Florence were to see the Passage of these Troops without occasioning any Disorder or Tumult,



Tumult, contrary to what happened at Pisa, and which the Government were to apprehensive of on the Part of the People, that the few Cannon that are left in the two Castles were charged and pointed against the Town, except the first Day the two Gates of the Town which by they passed were shut when they came within Sight of M. de Castellar, who commanded the first Column, on Notice that a large Party of his Men had at once deferted, at the Instigation, as he pretends, of some of the Great Duke's Officers, and that they were in one of the Castles at Florence, wrote a very strong Letter to the Spanish Agent to bid him demand them, and to threaten the Government, that unless they were delivered up, he would leave a strong Body of Troops at all the Avenues of Florence, to prevent the like Inconvenience for the future. The vent the like Inconvenience for the future. Spanish Agent sent Marquess Castellar's original Letter to Prince Craon, accompanied with one much stronger from himself. The Regency refused however on this arbitrary Demand to give them up, but immediately fent an Officer to M. de Castellar to make some Sort of recipiocal Agreement with him on this Head.

Genoa, March 14. Letters from Madrid of the 27th past mention the Departure of Don Philip, after having, as is therein said, received the Investiture of the Dutchies of Milan, Parma and

Placentia, from the new Emperor.

Vienna, March 14. By a Letter from Budeweis of the 12th Instant, we are informed that the French had found Means to throw a Reinforcement into the Castle of Frauenberg, which lics upon the Mulda, between Budeweiss and Piteck, and had been reduced to the last Extremity for Want of Provisions, and by Sckness, so that we were in hourly Expectation of its Surrender. This was effected by a Detachment of about 2000 Foot and 1200 Horse, which they sent on the 9th Instant, under the Command of the Duke de Boussers, the Duke de Brisac, and the Chevalier de Broglio, who marched all Night, dislodg'd a Party of Hussars at Potewin, surprized the little Town of Wodnian in their Way, where they made 130 Prisoners, exchanged the Garrison of Frauenberg, and put a sufficient Quantity of Provisions and Ammunition into it, and then returned to Pifeck, having again abandoned Wodnian. The French were obliged to pass and repass almost through the Middle of the Austrian Quarters for this Expedition. It is the Situation upon the River which makes the Castle of Frauenberg of any Importance, as hindring the immediate Communication by Water between Budeweis and Tayn. The Sickness is general in Bohemia, not only amongst the Soldiers of both Armies, but amongst the Peasants, and even the better Sort of People, who are in equal Want of all Neces-faries. Prince Lobkowltz is arrived at Wait-hoven, where the main Body is assembling in order to enter into Moravia. Four Deserters from General St. Ignon's Avant Guard at Waithoven having been examined, as is faid, for above an Hour, by the King of Prussia at Znaim, his Prussian Majesty has retired from thence to Iritz, and left the Town to be possessed by the Saxons. We are in daily Expectation of some important Accounts from Marshal Khevenhuller, who has extended himself beyond the Leck. There is hardly a Day now but we have fome Troops passing through this Town, or in the Neighbourhood from Hungary. There is a Report as if Count Rudolph Palfi had destroyed another Body of 800 Bavarians near Ingolftadt, faid to be the Regiment of Freifingen.

Berlin, March 20. By Advices from Upper Silesia there is an Account, That on the 10th Instant in the Night, a considerable Number of the Austrian Hussars broke into the Suburbs of Olmutz, which they plundered during the Space of two Hours, till the Garrison of the Town beat to Arms; after which they retired to about a Mile Distance, where they joined another Body of Hussars of about 600. They have done a great Deal of Mischief at Olmutz, and among other Things, they have carried off 70 Artillery Horses, two or three Officers, a great deal of Baggage, some of the King of Prussia's Domesticks, and his head Groom, with 18 of his Mules, and 12 of his Saddle Horses.

Dresden, March 21. The Hussars are extremely troublesome in Moravia; they have lately taken a Captain in Schonberg's Regiment, who was carrying some particular Orders to his Colonel; and afterwards attacked three Companies of the said Regiment drawn out in a Plain, but with what Success is not published here. They have likewise taken two Prussian Officers at the Gates of Olmutz; and that Corps of Hungarians which entered Silesia by Jablunka, is, by Letters of the 17th Instant from Breslau, got to Oppelen, but will scarce be able to cross the Neiss without meeting with General Marwitz. His Prussian Majesty is expected here, as is likewise the Emperor, but the time of their coming seems uncertain.
