HE Swedish Deputies are arrived here, namely, Count Bonde, Baron Hamilton, and Baron Sheffer; but they have not yet had an Audience of the

Czarina, or the Great Duke.

Oporto, Dec. 31. Captain Lofting of His Majesty's Sloop the Wolf, has put about 30 Hands on Board the Spanish Privateer Schooner, which he lately took at Marin, in the Entrance of the River of Porto Vedro, and has made her a Cruizer, whereby she will be very serviceable for the Protection of the Trade here, as she goes well, and will be able to keep as close in with the Shore as any of the Privateers. The Fly is come from Lisbon, and is now off this Bar, and a small Sloop of Eight Guns and Forty Men, having a Letter of Marque, hath been fitted out here by some Members of the Factory, and is also cruizing upon the Coast, so that the Trade to this Port is sufficiently secured from being annoyed by the Privateers out of Galicia.

Prague, Jan. 9, N.S. We are here taking an Inventory of all the Effects left by the French, and yielded by Capitulation to her Majesty; among which we have found a great Number of Cannon, and seven hundred thousand Cartouches charged. All the Queen's Troops, excepting this Garrison, are already upon their March towards the Upper Palatinate. We hear from Egra, that the French have left only one thousand Men to

gatrifon that Place.

Vienna, Jan. 19, N. S. By the breaking up of the Ice in the Danube upon the late Thaw, the great Bridge call'd the Bridge of Tabor was carried away, and we hear that the Bridge at Crems was likewise destroy'd. Sir Everhard Fawkener, his Britannick Majesty's Ambassador to the Porte, arrived here the 16th instant from Constantinople in his Way to England.

Naples, Jan. 8. Last Week Mustasa, Bey of Berno, had his first Audience of the King, to compliment him on the Part of the Bey of Tripoli, and presented to his Majesty 15 Barbary Horses, two white Dromadaries, a Lyon, two Tygers, &c. which that Bey sends to the King.

Turin, Jan. 12. The King of Sardinia's Army, after having less the Camp at our Lady

Army, after having left the Camp at our Lady of Mians, and retired to Montmeillan, continued its Retreat in two Columns in good Order, by two different Roads. The Rear Guard of both was attacked and harrafled, during the

March, by Detachments of Miquelets and Spanish Grenadiers; but they were briskly received, and were neither able to do us much Harm, or to diforder us in our Retreat. The utmost of our Loss amounts to about fifty Men killed, and between three and four Score wounded; amongst which only three Officers. The Loss of the Spaniards exceeds three Times that Number, and our Army, Artillery, Stores and Provisions are all now on this Side of the Alps.

Rome, Jan. 12. On the 27th past a Party of Sbirri went into the Jurisdiction of Spain; to take up a Person without the usual Permission; whereupon the Porters of the respective Palaces in that Neighbourhood fell upon them, killed three of them, and mortally wounded five more. On the 29th an Express arrived from Milan, with Notice, that on the 23d died Cardinal Stampa, Archbishop of that City; and Cardinal Cibo; the last Male Fleir of the House of Massa, is since dead here. Cardinal Fini has renounced to the Pope all the Abbies and Ecclesiastical Benefices possessed by him, having, out of them, reserved to himself a yearly Pension of 1500 Crowns. The Pope has hitherto taken no Determination concerning the Request made to him by the Court of Naples, &c. to diminish the Festival Days of the Year.

Florence, Jan. 15. N. S. M. de Gages has lately been attacked with a very severe Fit of Illness; there is likewise an Epidemical Fever among his Troops, of which many have died. By the last Letters from Lombardy, we are informed, that Marshal Traun, on Notice of M. de Gages's Designs to set Fire to the Magazines of Provisions, Ammunition, &c. of the Austrians, at Revere, on the 28th past, invited M. de Apremont to a Conserence at Carpi, in order to prevent that and any other Surprize the Spaniards should attempt in the Modanese; in Consequence of which, Directions were sent to the Sardinian Troops, distributed in Winter Quarters in the Parmigiano, Piacentino and Pavese, to hold themselves in Readiness to march.

Geneva, Jan. 25. N. S. The Resolution of demanding a Body of 800 Men from the Cantons of Zurich and Bern, for the Security of this City, having been taken by the General Council, those Troops are now expected here every Day. Notwithstanding the fair Promises of the Marquis de Eusenada, first Minister of the Infant Don Philip, the Spaniards have quarter'd Troops upon our Estates of St. Victor and Chapter.

Chapter, who commit divers Excesses there. The Spaniards in the Dutchy of Savoy, are entirely ruining the whole Country. They plunder the Boors of all their Seed and Forage, fo that in a little Time they will be forced to kill their Beafts for Want of wherewithal to feed them. This affords a very bad Prospect for us as well as for the Savoyards. It it impossible that any Place can be in a more miserable Condition than Chamberry now is.; it is no longer a rich Town, for the Inhabitants are obliged to provide every Thing necessary towards furnishing the Hospitals for the Lodging of 4000 Men, and the whole Court of the Infant; and if the most trisling Thing be wanting, the Sindicks have immediately fifty Soldiers quartered upon them, who live at Discretion. All the other little Towns of Savey are used in the same Manner. Don Blaize, Envoy Extraordinary from Spain to the Helvetic Body, has fent his Secretary to Zurich, to present his Credential Letters. In them the King of Spain stiles himself Duke of Milan. These Letters have been read in a Grand Council at Zurich, and they have been communicated to the other Cantons, whose Sentiments upon the Matter are expected, that a proper Answer may be given to Don Blaize. The Title of Duke of Milan will greatly embarrais some of the Cantons, upon Account of their Agreement with the House of Austria concerning the Mila-

This being the Birth-Day of his Royal Highness the Prince of Wales, the Great Guns were fired at the Barracks, and answered by Vollies from the Regiments in Garrison, which were drawn out upon Oxmantown Green. At Noon the Lords Justices received the Compliments of the Nobility and other Perfons of Distinction, who appeared at the Castle upon this Occasion. In the Evening there was a Play given by their Excellencies, for the Entertainment of the Ladies. And at Night there were Bonfires, Illuminations and other Demonstrations of Joy.
