- (B1) THE LLP'S INCORPORATION DOCUMENT
- (B2) ANY DOCUMENTS MAKING OR EVIDENCING AN ALTERATION IN AN LLP'S INCORPORATION DOCUMENT.
- (B3) ANY NOTICE OF THE CHANGE OF THE LLP'S NAME.
- (C1) NOTIFICATION OF ANY CHANGE AMONG THE LLP'S MEMBERS
- (C2) NOTIFICATION OF ANY CHANGE IN THE PARTICULARS OF MEMBERS REQUIRED TO BE DELIVERED TO THE REGISTRAR
- (D1) ALL DOCUMENTS REQUIRED TO BE DELIVERED TO THE REGISTRAR UNDER SECTION 441 (ANNUAL ACCOUNTS) AS APPLIED TO LLP'S BY THE LIMITED LIABILITY PARTNERSHIPS (ACCOUNTS AND AUDIT) (APPLICATION OF COMPANIES ACT 2006) REGULATIONS 2008.
- (D2) THE LLP'S ANNUAL RETURN.
- (E1) NOTIFICATION OF ANY CHANGE OF THE LLP'S REGISTERED OFFICE.
- (F1) COPY OF ANY WINDING-UP ORDER IN RESPECT OF THE LLP.
- (F2) NOTICE OF THE APPOINTMENT OF LIQUIDATORS.
- (F3) ORDER FOR THE DISSOLUTION OF AN LLP ON A WINDING UP.
- (F4) RETURN BY A LIQUIDATOR OF THE FINAL MEETING OF AN LLP ON A WINDING UP.
- (L1) NOTICE IS HEREBY GIVEN, PURSUANT TO SECTION 1031 OF THE COMPANIES ACT 2006 AS APPLIED TO LLP'S BY THE LIMITED LIABILITY PARTNERSHIPS (APPLICATION OF COMPANIES ACT 2006) REGULATIONS 2009, THAT THE LIMITED LIABILITY PARTNERSHIPS LISTED HEREUNDER HAVE BEEN RESTORED BY COURT ORDER TO THE REGISTER OF COMPANIES.
- (L2) NOTICE IS HEREBY GIVEN, PURSUANT TO SECTION 1027 OF THE COMPANIES ACT 2006 AS APPLIED TO LLP'S BY THE LIMITED LIABILITY PARTNERSHIPS (APPLICATION OF COMPANIES ACT 2006) REGULATIONS 2009, THAT THE LIMITED LIABILITY PARTNERSHIPS LISTED HEREUNDER HAVE BEEN ADMINISTRATIVELY RESTORED TO THE REGISTER OF COMPANIES.
