His Majesty in Council was this Day pleased to declare his Grace Lionel Duke of Dorset, Lord President of his Majesty's most Honourable Privy Council, and his Grace took his Place at the Board accordingly.

His Majesty in Council was this Day likewise pleased to declare the Right Hon. Philip Earl of Chesterfield, Lord Lieutenant of the Kingdom of Ireland, in the room of his Grace William Duke of Devonshire, whom his Majesty hath appointed Lord Steward of his Household.

This Day the Right Hon. John Lord Hobart and George Dedington, Esq; were by his Majesty's Command, sworn of his Majesty's most Honourable Privy Council, and took their Places at the Board accordingly.

The King has been pleased to constitute and appoint the Hon. Roger Townshend, Esq; to be Governor of the Fort and Batteries of the Town of Yarmouth in the County of Norfolk, in the room of Gerrard Russell, Esq; deceased.
