Naples, Feb. 2, N. S. The King's Field Lyuipage is preparing with the greatest Expedition, which gives Occasion to a Report, that his Majesty intends to put himself again at the Head of his and the Spanish Army. An Edict was published here last Week, promising a general Pardon to all Deserters, both Horse and Foot, who, within the Term of 40 Days from the Date thereof, shall return to their respective Regiments, or surrender themselves to the Governors of the Fortresses of the Kingdom.

Rome, Feb. 6, N. S. Supplies of Provisions daily arrive here from Naples by Sea and Land, for the Spanish and Neapolitan Armies.

Florence, Feb. 9; N. S. The Army under Count Gages had actually began their March towards Foligno in their Way to Tuscany, and Orders had been given for 10,000 Rations of Bread to be ready for them upon the 5th at Perugia, when a Courier arrived from Naples with Orders to stop the further March of the Troops, whereupon they all returned to their old Quarters at Viterbo, Orvieto, Terni, Narni, Spoleto, &c. The Austrian Army continues in its usual Situation, and begins to be reinforced every Day by Recruits from Lombardy and Germany. On the 1st of this Month, 500 Men of the Pope's Troops that were raised in the last Summer, having been dismissed, and their Regimentals taken from them, Cardinal Acquaviva, who had previous Notice of this Design, inlisted most of them into the Spanish Service. A Party of Austrian Hussars lately surprized a Body of 400 Spaniards in the Neighbourhood of Orvieto, and defeated them; one hundred and fifty of the wounded Count Gages ordered to be sent to the Hospital at Monte Rotondo. A Report prevails in this City, that an Infurrection has lately happen'd amongst the Inhabitants of Corfica against the Genoese Government. A third Regiment of Militia is raising in Tuscany, which is to be compleated by the latter End of next Month.

Francfort, Feb. 20, N. S. What we have been expecting for some Time past, viz. that the French Troops quarter'd on this Side of the Mayn, as far as the River Lahn, would not wait the Approach of the Combined Army now marching from the Lower Rhine, but retire back over the first mentioned River, has now happened: For not only those that were quar-

ter'd

the Mayn, on the 18th, but also these who were posted on and about the Lahn, after a forced March of 10 Hours, did the like Yesterday and this Day, leaving behind them the Magazines they had erected: Those who had been quarter'd at Aschaffenburg, and other Places up the Mayn above this City, marched this Day on the other Side of the River, in our Sight. They give out, that their Design is to take Possession of the advantageous Camp near Trebur; but as they will find no Forage, nor other Necessaries, in that Country, which they have already entirely exhausted, and in which they have not prepared any Magazines beforehand, this is thought to be only a Blind to cover-the true Motive of their Retreat, which is attributed by every body to the Approach of the Confederate Army. This precipitate Flight of the French Forces occasions great Joy here, and in all the neighbouring Parts.

Bonn, Feb. 22. By Letters from Mentz there is Advice, that the Elector has distributed Powder and Ball to the Burghers, and appointed the Posts at which they are to assemble in Case of an Alarm; and that the French have laid a

Bridge over the Rhine near Worms.
