Petersbourg; February 26. traordinary and Plenipotentiary, fet but from hence in order to return to England. Noples, Morch 2, On the 24th paft the Duke Barretta, Agent Victualler of the Spanish Army, received Orders from M. de Gages, not to fend, as usual, the Forage for the faid Army to Civita Vecchia, but to direct the Oats and Corn to Ancona, The Train of Artillery which the King of Naples is to furnish to M. de Gages's Army, is getting ready with the utmost Expedition. The Neapolitan Troops which the King fends to reinforce the faid Army, confifting, as is faid, of 15 Battalions and nine Squadrons, are in March in four Columns, the first proceeds by Villetri, the second by St. Germano and Valmonte, the third by Rieti, and the fourth by Aquila. On the 27th paft M. de Montalegre, Secretary of State, was taken ill of a Fever. Florence, March 9. Three Couriers from Spain have within these few Days passed by in " their Way to M. de Gages, who it is supposed were charged with the final Inftructions to him: Since their Arrival at the Spanish Camp, M. de Gages has given fresh Orders to assemble his Troops, and caused forme Piquets to advance to Foligno. By Advice just received, the whole Army was in Motion with 30 Pieces of Cannon in two Columns, one was to march by the Route of Foligno, and the other by Perugia. It has been publickly faid at Viterbo, that the last Courier from Spain brought Orders to M. de Gages to march-directly towards Prince Lobcowitz's Army, and to attack the Auftrians at all Events; but an Opinion still prevails that they have a Defign on Tuscany. Letters from Naples bring an Account, that the King of Naples will not move from thence himfelf, but that he will fend 15 Battalions to reinforce M. de Gages, great Part of which by the last Accounts was already in March. Bern, March 20, N. S. M. de Ravoy, the French Governor of Constance, is carrying off and fending into Alface, all the Artillery and

Berlin, March 23, N.S. His Pruffian Majefty arrived upon the 17th of this Month at Breflau. The Warlike Preparations are continued here with great Diligence. Seven bunt dred and twenty fix Horses, and 448 Men belonging to the Train, are expected here this Week, in order to conduct the Artillery and feveral Carriages full of Ammunition into Silefia. Berlin, March 27, N.S. It is faid that the Reigning Prince of Deflau will return here in a fhort Time, to take upon him the Command of a Body of Troops which is to be allembled in this Neighbourhood, and that it is in this View that the Regiments which are in Garrison here, have Orders to hold themfelves in Readiness to march about the 8th of next Month; but as yet we are ignorant of their Destination. The Artillery is not yet fet forward, but the Horfes ordered for that Service are arriving Some Boats of this Place, and feveral belonging to Magdebourg, are, it is faid, ftop'd and impress'd, in order to their transporting some Part of it by Water to the Oder. Hambourg, March 23. It is faid that 40,000 Recruits have been railed fince the Campaign in Bohemia to compleat the Pruffian Army. A Train of Artillery, and other Ammunitions of War, are ordered for Silefia as foon as the Oder shall be navigable. We hear from Petersbourg, that the Rufflan Fleet will put to Sea this Spring, and that the Gallies are likewife to be equipped. Hambourg, March 30. An English Vessel called the Recovery, of about 100 Tons, laden with Butter, Tallow, fome wrought Iron and two Bales of Woollen Goods, was taken, in her Passage from Newcastle to London, by a Privateer from Calais, and has been fince retaken at Sea by two Coal Ships, bound to Hambourg, and they brought her in here the Day before Yesterday; they found on board fix Frenchmen and a Boy, but Yesterday Morhing one of the Frenchmen made his Escape while the Men were buly in delivering their Coals. The

The faid Veffel was put into the provisional Pollession of Capt. Osborne, of his Britannick Majesty's Ship the Shoreham, which lately arrived in this River, as Convoy, together with the Gibraltar, to the Trade from Hull. The King of Poland's Minister at the Court of Vienna, Count Bunaw, having obtained Leave to absent himself some Months for the Recovery of his Health, his Polish Majesty has appointed M. de Gersdorff, his Minister Plenipotentiary at the Court of Vienna, during the Absence of Count Bunaw. By the Deaths of the Lieutenant Generals Messieurs de Marche and de -Grumkaw, in the Saxon Service, the Governments of the Fortress of Pleissenbourg at Leipfick, and of Sonnenstein at Pirna, are become vacant. The King of Pruffia who arrived at Breflau the 17th, was preparing to fet out for Neifs. His Majesty has made a Promotion of General Officers.

Mentz, March 24, N.S. The French having threatned to enter into the Rhinegow and pillage all that Country if the three Chiefs of the Peafants, who had fired upon their Boats were not deliver'd up to them, this brought on a Negociation which ended in a Convention that the 15 Peafants, who had been taken up by the Elector's Order should be fent to the French Camp, under Condition that they should be pardon'd, and fent back to the Elector, which has been executed accordingly. Marshal Maillebois's Quarters are now at Ober-Urfel, and Yesterday Morning General Lowendal marched to Epstein, where he is with the Left of the French Army, fo that there is still Five or Six French Leagues between their Line and the Lahne, the Marshal has demanded Leave to enter into Konigstein, and threatens to attack it unless it be put into his Hands. A Conference has been held hereupon, but the Refult of it is not yet made publick. Mentz, March 27, N.S. M. de Agion, who is here on the Part of M. de Maillebois, (in the Absence of M. de Blondel the French Minister) has been at Court this Afternoon, and demanded peremptorily, that the Fortress of Konigstein should be immediately delivered up to the French, threatning, in cafe of Refusal, that they will take it by Force, declare War openly against the Elector, put his Country under Contributions, and blocade the Town of Mentz in Form. To this the Elector has taken the Refolution to declare, that he will not deliver up his Fortrefs, but abide the last Extremity, appealing to the Empire, and to the Neutrality stipulated for his Country, which he has hitherto religiously obferved. The French have begun to fet up a Bridge of Boats below this Town at Biberich, fo that we are blocaded on all Sides, and in a kind of Prison at large in this Town. Hague, April 2, N.S. The Prince of Orange and the Princess Royal set out this Morning for their usual Refidence in Friseland. The Prince of Waldeck is still here, but is upon the Point of his Departure for Flanders, whither Sir John Ligonier fet out this Morning. Monfieur Elfacher, the Palatin Resident here, has mo-

ved the Ministers of this Republick in his Mafter's Behalf, with respect to obtaining a less rigorous Treatment of his Estates at the Hands of the Queen's Troops, alledging in Support of this Sollicitation, that the Elector is resolved not to trespass the Rules of a perfect Neutrality. And it is further reported here, that the Orders and Preparations for putting the Palatin Troops, which are in the Dutchy of Juliers, into a Condition to take the Field, have been unexpectedly countermanded and fuspended.
