Lobcowitz's Army having been reinforced to the Number of 18000 Men, he had divided the same into three Corps, one of which had been fent to L'Aulla and Pontremoli; the other two were to march the 15th Instant, or sooner if the Exigencies of Affairs required. Yesterday arrived an Estafette from that Prince to the Queen of Hungary's Agent, with Orders to him to acquaint the Republick, that the Situation of Affairs would probably oblige her Hungarian Majesty's Troops to enter this State very soon, and to require that the Republick would give the necessary Orders, that they may be provided with Provisions of all Kinds, and Forage, which will be paid for in ready Money, and the Troops observe a strict Discipline. M. de Gages's Army is atrived between Lucca and Sarzana, and has exacted large Contributions from the State, but it is with Difficulty that they find Subsistance. A few Days ago all the Flower and Bread in Town was bought up to be fent to his Camp, and was upon the Road, but a Body of Hussars, who were waiting for another Convoy that was going to the Army, coming down from the Mountains of Cento Croce to Verese, the Mulateers getting Intelligence of their being on the Road, they deposited the Provisions at Chiaveri. Don Phillip's Army is moving forward; the Cavalry was expected to arrive at Nice two Days ago, and was to continue their Route to Albenga, where the Infantry and the whole Army are to joyn. Letters from San Remo advise, that Convoys of Mules from Nice pass through that Town Day and Night, with Flower, Bread, Barley, and other Provisions, for the Army, his Britannick Majesty's Ships on this Coast having prevented their receiving any Supply by Sea. His Sardinian Majesty has published an Edict, to oblige all the Inhabitants in the Alexandria and Tortonese States to carry their Arms to the respective Governors of the Towns, under Penalty of a Confisca-

tion of Goods and Estates. This Republick continue their military Preparations with the utmost Vigour, as well in raising new Troops, as in fortifying this City and their other Garrison Towns. They have sent a Reinforcement of a thousand Men into the Castle of Gavi, and the like Number to Porto Specia. Just now arrived his Britannick Majesty's Ships the Guernfey, Roebuck, and Chatham, the two first from Lisbon, and the last from Vice Admiral Rowley's Fleet, who he left eleven Days ago cruizing off Carthagena, having taken and destroyed several Vessels belonging to the French and Spaniards.

Mentz, May 20. The Duke of Aremberg has broke up his Camp, and retired with his Army behind the Wied, and accordingly 4000 Horse were ordered to repass the Rhine on the 16th and 17th Instant, and march down the River to a Place opposite to Neuwied, where the Bridge at Vallender, which was taken down, is fince ordered to be rebuilt; and on the 17th, at Break of Day, the whole Army began to file off towards Neuwied, by the Plain of Roemmersdorff. Upon the first News of these Motions, the French retook Possession of Nider Lahnstein in the Night between the 16th and 17th, and began to throw a Bridge over the Lahne. They have fince demanded 90,000 Rations from the Elector of Treves; and it was expected at Coblentz, that the Prince of Conti would march with his Army and take Possession of the Camp which the Allies have quitted.

Copenhagen, May 22. The King and Queen of Denmark are expected in Town this Evening, being to spend all the next Week here on Account of the Reviews. In a Day or two the Prince and Princess Royal come hither to take Possession of a Palace newly fitted up for them, which was the Residence of his Majesty when Prince, where they propose to continue till-after her Royal Highness has lain-in. The Princess, upon her going into the Country while the North-Easterly Winds blew very fresh, had the Misfortune to get a Cold, accompanied with a Fever, the Violence whereof was such at first, as

gave great Apprehensions of some fatal Accident, but her Royal Highness is now out of all Danger, and pretty well recovered. The affectionate Care and Concern of the Queen appeared on this Occasion. Her Majesty, it is said, attended the Princess two Days and a Night, and would not leave her as long as any ill Symptom remained.

Berlin, May 22, N.S. The Quarter-masters of the Regiments which are to form the Camp near Magdebourg are still here, but the Officers are getting themselves ready to go thither; and the Prince of Darmstadt, who is come back from Silesia, set out for that Place Yesterday Morning. All that we hear from Silesia is, that the King of Prussia is still at Kamentz; that the Army continues still in its Quarters of Cantonment, without making any Motions to incamp,

Whereas by an Act passed in the last Session of Para liament, intitled, (amongst other Things) An Att for giving farther Time for the Payment of the Duties omitted to be paid for the Indentures or Contracts of Clerks and Apprentices, and for the further inforcing the Payment of the Said Duties, it is Enacted. And for the better enforcing the Payment of the said Duties, it is Enacted, That after the 24th of June next, if any Master or Mistress shall neglect to pay the said Duties within the Times limitted by the said A81, they shall for every such Neglest forfeit and pay double the Duties charged and directed to be paid by the said former Atts (over and above all Penalties and Forfeitures thereby inflicted) for all Moneys which shall after the said 24th of June be given, paid, contracted, or agrud for, with or in Relation to every such Clerk, Gc. to be paid by the said Masters and Mistresses; and if they shall neglect to pay the said Duties charged by the said former Acts, within the Times therein limitted, and any such Clerk, Apprentice or Servant shall in that Case pay the said Duties and the Penalties incurred by this Act, within one Year after the same hell become charged and made payable thereby, (such Mass ter or Mistress not having thez paid the same, ak though required so to do that then it should be lawful for 'the Clerk, Apprentice or Serwant, within these Months after such Payment, to demand of the Master or Mistress, their Executors or Administrators, the Money paid to them in respect of such Clerkship, Ap. prenticeship or Servitude: And in case the Money shall not be paid, within three Months after such Demank made, it shall be lawful for the Clerk, Apprentice of Servant to sue for the same against the Master of Mistress, their Executors or Administrators; and after Payment of the said Duties, Penalties and Forfeitures, the Clerk, Apprentice or Serwant shall be discharged from their Clerkship, Apprenticeship and Service, and from all Actions and Damages for not Jerwing their Time, and shall have the Advantage of the Time they shall have served such Master or Mistress, as the might have done in case of any Assignment or turning over to any new Master or Mistress.
