GOD Save the King.

Vienna, Feb. 22, N. S. Yesterday Morning their Imperial Majesties reviewed the Second Column of Lycanians, that are going to join the Army in the Low Countries. They were 1000 Men compleat, and had Prince Hild-burghausen, who has raised and disciplined them, at their Head, and gave entire Satisfaction to all who saw them. As soon as the Review was over, they pursued their March, and will be followed next Week by a Column of Hussars of the same Nation.

Liege, March 3, N. S. The Roads from Germany to the Low Countries are full of Imperial Troops, which follow successively. The Infantry, for the greater Expedition, are carried down the Rivers in Boats.

Hague, March 7, N. S. We hear from Brussels, that Marshal Saxe was expected there by the End of this Week; and some Persons belonging to his Houshold were already arrived. And from Paris, that the Field Equipages of the French King were ordered to be in Readiness for his Journey to the Netherlands, where he proposed to be by the Middle of April.
