Moscow, August 28:

HE Empress proposes to return to Petersbourg towards the Beginning of next Year. The late Duke of Courland's Daughter, Mademoiselle de Biton, who has been here about fix Weeks, has embraced the Greek Religion, and has been baptized with great Solemnity by Order of her Imperial Majesty, who has appointed her an Apartment in the Palace, and made her one of the Ladies of her Bed-chamber.

Lishon, Sept. i. A Decree has lately been published here, by which the Presidentships of all the Tribunals which had remain'd vacant some 30, and others above 40 Years; have been of a sudden fill'd up by Noblemen of the first

Rank and Merit in the Kingdom.

Naples, Sept. 2. The Court having received certain Information that the Algerine Rovers continue greatly to interrupt the Trade and Navigation of Sicily, have given Orders for all the Gallies in this Port immediately to put to Sea again.

Petersbourg, Sept. z. 'Tis thought the Fleet will put no more to Sea this Year; as several Frigates are already come from Revel to Cronfladt, where they talk of laying them up; in the mean time, all the foreign Merchant Ships in these Parts are preparing to return to their respective Countries before the setting in of the ftoffy Weather.

Ratibor, Sept. 6. The Locusts have done great deal of Mischief in the neighbourhood of this Place, particularly in the Lordship of Rubhig where they have entirely devoured a great Quantity of Barley, Oats, and Millet; and our Accounts from Silesia are full of the great Hatock they have made in several Parts of that Country.

Augsbourg, Sept. 9. The Duke and Dutchels of Bavaria arrived here Yesterday from Manbeim, and having spent a sew Hours in Dining, and viewing the Cathedral, set dut in the Af-

ternson for Munich.

Venice, Sept. 12. Several Alterations have happened amongst the foreign Ministers heres The Marquis Scoti, Ambassador from Spain, has been recalled, and is replaced by the Duke of Montalegre, formerly Minister to the King of Naples. M. Montaign, the French Ambassadors is also recalled, and set out Yesterday upon his Return home, and M. Chavigni is talk'd of to succeed him. The Disputes which have so long subsisted between the Republick and the Religious of Malta being adjusted, that Order has sent one of their Knights to manage their Affairs, who has the Title of Ricevitor; which Character the Republick treat with particular Honours above those shewn to the Residents of crowned Heads. by admitting him to be seated and cover'd at his Audience, and to have the College Doors open. Sir James Gray, his Britannick Majesty's Resident to this Republick, arrived here on the 9th Instant.

Vienna, Sept. 13; N.S. The Empress Queent of Hungary set out the 10th Instant for the Camp at Salenau, where the was met by the Emperor from Hollitsch, and in the Evening her Imperial Majesty returned to this City. Count Caunitz, who is appointed Ambassador Extraordinary from this Court to that of France, has received the melancholly News from Moravia of the Death of his Lady in Child-bed, at Parlitz in that Kingdom. The Marquess Durazzo, Envoy Extraordinary from the Republick of Genda to this Court, arrived here a few Days ago, and will foon be admitted to an Audience of her Imperial Majesty. General Count Brown is also arrived here from the Camp at Pilsen, and wilk fet out in a few Days to take Possession of his Government of Transilvania. A large Quantity of Copper has lately been coined into Money and sent to Trieste and Fiume, which Places 'tis reported will soon be declared free Ports. The Court feems to apply itself with great Attention to the promoting of the Manufactures of the Hereditary Countries.

in the ending of the Diet.

Ratisbonne, Sept. 18. Count Bentinck arrived here from the Hague on the 14th, and having been visited by most of the Foreign Ministers, continued his Journey on the 16th for Vienna.

Franckfort, Sept. 18, N. S. Prince Frederick of Hesse Cassel, accompanied by General Donep, and the Barons d'Assebourg and Furstenberg, arrived here the 13th from Cassel, and on the 15th let out for Paris by the Way of Strasbourg. A few Days since a Fire broke out in the Town of Ebingen, which burnt with such Violence, that the Town-house, Post Office, and several other Houses, were soon reduced to Ashes.

-1 Hamburgh, Sept. 19, N.S. The Duke of Hildburghausen, accompanied by the young Prince his Brother, left Hamburgh the Day before Yesterday, and proceeded on their Route to

Denmark,

Hague, Sept. 23, N.S. The Prince of Orange returns hither on Thursday next to assist at the Assembly of the States of Holland, where it is supposed the Plan for the Reduction of the Troops of this Republick will be taken into Consideration. It is expected, that there will soon be held a Diet in Guelderland, at which the Deputies from that Province, as well as those from Holland, Utrecht, and Overyssel, will be present, in order to fettle the Affair of the Bridge of Panbern, which at present obstructs the free Course of the Water, and may thereby cause some violent Inundations. It is reported, that M. d'Ammon, Envoy from the King of Prussia to this Republick, is preparing to leave this Place, having received his Letters of Revocation.

Hague, Sept. 24, N.S. The States of this Province will open their Assembly To-morrow.

Prague, Sept. 13. Advices from divers Places | We hear from Loo, that the whole Court atrived there the 19th Instant, in perfect Health, from whence his Serene Highness is expected back here this Evening. M.
