Chibusto in Nova Scotia, August 20.

HE Town is laid out, and every Man, by drawing Lots, knows where to build his House. The Governor has made the best Disposition he can of the Troops, in order to guard against any Attempts of the Indians, should they begin to betroublesome. Thirteen Indians are arrived here, three Deputies from the Tribes at St. John's, the Chief of the Chinecto Indians, and nine of their Tribes; they came with Instructions from their Nations to renew their Submission, and Articles of Agreement, according to the last Treaty made in the year 1726: and this Afternoon they return by Sea to St. John's with Captain Howe, who carries Presents for the Chiefs and the whole Tribes, and is to bring back the Treaty ratified.

Moscow, Sept. 9. The Empress having conferred the Order of St. Andrew, vacant by the Death of the late Charles Leopold, Duke of Mecklembourg, on the present Duke of that Country, the Enfigns thereof were Yesterday delivered by her Imperial Majesty to M. Berckholtz, his Minister at this Court, who will set out with the same in a few Days, having already taken his Leave, and received the usual Presents. Her Imperial Majesty has presented Lord Hyndford with her Picture set in Diamonds, valued at 12,000 Rubles. Last Friday a Grand Council was held in the Empress's Presence, at which the Senate, all the Great Officers of State, the Ministers for Foreign Affairs, together with the Great Council of War, and the College of the Admiralty, assisted; in which, 'tis said, some favourable Resolutions were taken with regard to the Peace in the North. Her Imperial Majesty having notified 'to the Senate her Resolution of returning soon to Petersbourg, Orders have been issued for the whole Court to hold itself in Readiness to set out on the first Notice.

Petersbourg, Sept. 13. The Inhabitants of this City seem mightily pleased with the Advice they have received from Moscow of the Court's Intention of teturning soon to this Place. 'Tis expected that the Troops, which are at present cantonned in and about Livonia, will go into Winter Quarters towards the End of the Month, however so as to be easily drawn together again in Case there should be any Occasion for them.

Madrid, Sept. 16. The Bishop of Oviedo, heretosore Governor of the Council of Castile, to whom the King had given the Bishoprick of Plaisance in Estramadura, has obtained his Majesty's Leave to retire to his Bishoprick. Orders

have been sent to all the Ports of this Kingdom, for keeping the Navy upon a better Footing than it was during the late Reign.

Genoa, Sept. 17. The Nobility and Citizens having complained to the Government of several seditious Papers, which have lately been stuck up in divers Parts of this City, many suspected Persons have been thereupon taken into Custody, and Prosecutions are ordered to be commenced against them. M. Chauvelin, the French Minister, having received Advice from his Court of his being raised to the Degree of Lieutenant General; he immediately acquainted the Doge therewith, and the Day after gave a grand Entertainment to several Persons of Distinction on that Occasion.

Prague, Sept. 24. The Troops which were garrisoned in this City, and which have been for some Time past encamped, will come hither again towards the End of the Month; and some Companies of Cuirassiers of the Regiment of Lobkowitz have also Orders to come hither at the same Time, to take up their Winter Quarters.

Vienna, Sept. 24, N. S. Count William Bentinck, Minister from the States General, has been to the Palace of Schonbrun, in Company with the Baron Burmania, their High Mightinesses Envoy Extraordinary to this Court; he was presented to their Imperial Majesties, and met with a most gracious Reception. Count Kaunitz is arrived here from Moravia, in order to make Preparations for his Journey to Paris, where he is appointed to reside as Ambassador from this Court:

Dantzick, Sept. 26, N.S. We learn by different Advices received from Poland, that a contagious Distemper rages pretty much in Walachia and Moldavia.

Stockholm, Sept. 26. The Prince Successor arrived Yesterday at Eckholmsund from the Tour he has made through several Provinces of this Kingdom to review the Troops and visit the Fortifications, where he was met by the Princess his Spouse; it thought they will rest there a Day or two, and then proceed to Drotningholm; from whence they will come to this City. His Swedish Majesty has lately promoted several Officers in his Army; he continues to enjoy a pretty good State of Health, and is often in the Senate deliberating upon the present Posture of Affairs.

Berlin, Sept. 27, N.S. The Marquis de Grimaldi, who has been here for some Days past, is set out on his Journey to Stockholm, where he is to reside as Minister Plenipotentiary from the Court of Spain:

Hanover, Sept. 30, N. S. The Great Chancellor Baron de Cocceii passed through this City Yesterday in his Way to Berlin. The Distemper amongst the horned Cattle has lately broke out again in several Parts of this Electorate, notwithstanding which, Provisions, which have been very dear, are now again become pretty reasonable, the late Season having produced very fine Crops. M. Guidickens, his Britannick Majesty's Minister to the Court of Russia, set out from hence on the 28th Instant for Bruns-

wick, in his Way to that Court.

Copenhagen, Sept. 30. The Duke of Saxe Hildburghausen, accompanied by Prince Frederick Eugene his Brother, and attended by a great Retinue, went on the 24th to Friedensbourg, to wait on the King, who received them with great Marks of Distinction; on the 26th they waited on the Queen Dowager at Hirscholm, and the next Day the Marriage of the Prince's Louisa, the King's Sifter, with the Duke of Saxe Hilbourghausen, was declared at Court, and will be celebrated in a few Days at Hirscholm. Vice-Admiral Tonder, who went on a Cruize into the North Sea to exercise the Seamen, is returned with his Squadron to Elseneur, having met with a Storm, in which one of his Ships has received great Damage. The contagious Distemper still continuing to rage amongst the horned Cattle in several Provinces of this Kingdom; the King, to prevent the spreading of the said Distemper, has caused an Ordonnance to be published, forbidding the holding of any Fairs or Markets for the Sale of any such Cattle, throughout the Diocese of Zealand, till further Orders.

Mayence, October 2, N. S. On the 26th past, the Elector of Mayence returned to Aschassenburg, from whence his Electoral Highness was to set out as Yesterday for a Hunting Seat in the Middle of Spessaerd, and proposes to re-

turn in 15 Days.

Hambourg, October 3, N. S. The Magistrates of this City have been obliged, upon Account of the Mortality which manifests itself anew among the horned Cattle in this Neighbourhood, to forbid the Entrance of any Oxen, Cows or Calves into Hambourg, or into any Part of their Territory, unless they be properly and duly proved to come from no suspected Quarter; nor are any Hides, or Blood of horned Cattle, permitted to be brought into Town, but what is, in a like manner, certified to be free of all Insection.

Paris, October 3, N. S. All the Foreign Ministers will set out this Week to follow the King to Fontainbleau. The Marquess de Puyzieulx, Secretary of State for Foreign Affairs, has been very much indisposed for some Days past. The Departure of the Infanta for Italy seems fixed for the 6th or 7th Instant, and according to the Route she is to take, she will reach Antibes before the End of the Month.

Dusseldorp, October 4, N. S. The States of Juliers and Bergues, who are now assembled here, continue their Deliberations with great Diligence. The Baron de Kerkering is gone to reside at Vienna in Quality of Minister from the Elector of Cologne. The Marquess d'Ittre, the

Elector Palatine's Prime Minister, arrived here a few Days ago from Brabant, and is waiting the Arrival of a Yacht to carry him to Manheim.

Brussels, October 5, N. S. Yesterday was celebrated here the Feast of St. Francis, whose Name the Emperor bears; the Court made a splendid Appearance on this Occasion, which ended with a Masquerade. On the 29th past a large Quantity of new coined Copper Money was brought from Antwerp to this City, in order to pay the Soldiers in Garrison here, except the Officers, who are to be paid in Silver. And on Wednesday last a Placart was published, regulating the Price of every Species of Gold and Silver Coin which are current in this Coun-

try, as well old as new.

Hague, October 8, N. S. Count de Wassenaer, Lord of Twickel, M. Bleyswyk, and M. de Raedt, are returned hither from Guelderland, and have reported to their High Mightinesses the Methods which appear to them most proper to be taken to prevent any Inundations which may happen from the Badness of the Bridge of Panbern. They met the Prince of Orange at Utrecht, and communicated to his Serene Highness their Thoughts upon this Subject; after which he proceeded on his Return to the Castle of Loo, where he arrived on the 2d Instant at Night. Sir Cyril Wych passed through this Place a Day or two ago for Hambourg.

Dublin Castle, September 20. His Excellency the Earl of Harrington, Lord

Lieutenant of this Kingdom, embarked at Parkegate Yesterday at One o'Clock in the Asternoon, and landed here about Three this Day.
