*Lisbon, September 21, N. S.*

**T**HE King having by a Convention with the Court of Spain obliged himself to send two Ships of War to cruize upon the Corsairs of Barbary, the *Star* of 60 Guns, and *la Notre Dame de la Pieté & St. Francois*, were appointed for that Purpose; they have accordingly been at Sea for some Time, and are now returned from their Cruize without having met with any of those Corsairs.

*Madrid, September 29, N. S.* The 26th Instant the Chevalier d'Offorio, in Quality of Envoy Extraordinary from the King of Sardinia, had a particular Audience of his Majesty, in which he presented a Letter from the King of Sardinia, containing a Demand of the Infanta *Dona-Marie-Antoinette* in Marriage for the Duke of Savoy; and the King having given him a favourable Answer, the Marquess d'Offorio immediately sent it by a Courier to the Court of Turin. Rear Admiral Spinola, with the four Ships under his Command, having on board near 16 Millions of Piastras, is not expected at Cadiz till the End of the Year, one of the Ships having suffered greatly in her Voyage from *La Vera Cruz* to the *Havanna*.

*Genoa, September 30, N. S.* Several Ships arrived here last Week from divers Ports in the Mediterranean, laden with Provisions and Merchandize for this City; and the Captains of those from *Corfica* and *Sardinia* say, that though the Corsairs of Barbary had Fourteen Galliots cruizing in the Italian Seas, they had not heard of their having taken any considerable Prize. The Algerines have also several Xebecks at Sea, but we do not hear of their having taken any Thing lately. We learn by Letters from *Barcelona*, that the Marquess de *Bonde Real* was arrived there, and would soon set out for *Parma*, where he is to reside as Minister Plenipotentiary from his most Catholick Majesty. The Mar-

quess de *Monti*, Colonel of the Regiment Royal Italian, in the Service of his most Christian Majesty, arrived here in three Days from *Antibes*, by whom we learn, that there were four Gallies lying ready at *Toulon* to sail for *Antibes*, to take on board the Infanta *Dutchess of Parma*, and conduct her to *Italy*.

*Stockholm, October 6, N. S.* M. de *Windt*, Minister from the King of Denmark, has had divers Conferences within these few Days past with the Ministers of this Court; and the Secretary of the Embassy of the States General has notified to the King, that their High Mightinesses had named the Count de *Wartensleben* to be their Minister Plenipotentiary to the Court of his Swedish Majesty.

*Vienna, October 8, N. S.* The Conferences which have been held for some Days past, have principally turned, as 'tis believed, on the Affairs in the North; and the rather, as a Courier is arrived here from *Moscow* with the Resolutions of the extraordinary Council which was held there the 5th of September. Advices from *Spielbourg* in *Moravia* mention the Death of the late Baron *Trenck*, in the Castle of that Place; he had commanded a considerable Body of Pandours during the late War, but was afterwards condemned to a perpetual Imprisonment. The 4th Instant, being the Feast of *St. Francis*, whose Name the Emperor bears, the same was celebrated at Court with the greatest Magnificence, all the Nobility and Foreign Ministers appearing at *Schonbrun*, to compliment his Imperial Majesty on that Occasion.

*Geneva, October 10, N. S.* Last Friday we received the agreeable News of his most Christian Majesty's having ratified the Treaty which M. *Mussard* had concluded with the French Ministers; on this Occasion the Magistrates of this City expressed great Satisfaction, and on the 7th gave a grand Entertainment to M. de *Champeaux*, his most Christian Majesty's Resident, to which the Duke de *Randan*, Lieutenant General

ral and Governor of Befancon, was invited ; and the next Day his Grace having seen all that is curious at this Place, set out for his Government of Befancon.

*Paris, October 13, N. S.* The King has named M. de St. Contest to be his Ambassador to the States General, and it is expected he will set out for the Hague in about a Month. Prince Frederick of Hesse Cassel has been for some Days at Fontainbleau, where he is treated with great Distinction, and often goes a Hunting with his Majesty. The young Prince of Nassau Weilbourg, who came hither with the Prince of Hesse, is set out for Lausanne. The Marquess de Puyzieulx, Secretary of State for Foreign Affairs, who has been very much indisposed for some Time past, is now perfectly recovered. The King has been twice to Choisy since the Court has resided at Fontainbleau. We hear from Toulon, that two Men of War, of 60 Guns each, were launched there the 4th of this Month. By Letters from Madrid we are informed, that they expect Sixteen Millions of Pieces of Eight to arrive at Cadiz, towards the End of the Year, from the West Indies.

*Hambourg, October 12, N. S.* We learn from Brunswick, that M. Guydickens, Envoy Extraordinary from the King of Great Britain to the Court of Russia, passed by there on his Way to Dresden, and was received in a very genteel Manner by the Duke and Dutchess of Wolfenbuttel.

*Hambourg, October 14, N. S.* Sir Cyril Wich arrived here last Saturday, the 11th Instant, from England.

*Leipsick, October 14, N. S.* Since the Arrival of their Majesties, a great Number of Foreigners of Distinction are come to this City to see the Fair, which 'tis imagined will be very considerable, as many Merchants are already arrived.

*Berlin, October 14, N. S.* The King has raised to the Dignity of a Count, M. Frederick William de Lepell, a Pomeranean Gentleman, Knight of the Order of St. John of Jerusalem, and Commander of Lietzen and Schiefelbein. His Majesty has appointed M. de Borke, Colonel of the Regiment of Stille, to be Governor of Minden, vacant by the Death of the late Colonel de Bornstedt ; and his Majesty has also appointed M. Witzleben to be Major of the Town of Stettin. M. Hinuber, Secretary to the Embassy of the King of Great Britain to the Court of Russia, arrived in this City on the 10th Instant. M. Fasch, the King's Agent and Counsellor of Commerce at Amsterdam, who has been here for some Time, is set out on his Return to his Post.

*Coblentz, October 17, N. S.* M. du Four, charged with the Affairs of his most Christian Majesty to the Elector of Treves, having received his Letters of Revocation, has had his Audience of his Electoral Highness, and will soon set out for France.

*Amsterdam, October 20, N. S.* The Magistrates of this City have published an Ordinance for the better Observance of the Sabbath-Day.

*Hague, October 22, N. S.* The Greffier Fagel, and the Secretary M. Hop, are returned hither from the Castle of Loo, where they left the whole Court in perfect Health ; and M. de Hasselaer is also returned hither from the Court of Great Britain. We learn from Middlebourg, that the States of the Province of Zealand separated Yesterday, and that the Baron de Borsselen was thereupon set out on a Tour to Guelderland. On Thursday last died, in the 86th Year of his Age, M. Christian Frederick Hertell, General of Infantry, and Director General of the Fortifications, having served the Republick with great Reputation ever since the Year 1684. We hear from Fontainbleau, that his most Christian Majesty has appointed M. de St. Contest, Intendant of Bourgogne, to be his Ambassador to their High Mightinesses the States General of the United Provinces. Mess. van Dyk and Buteux are return'd hither from Amsterdam, and have reported to their High Mightinesses the Result of the Deliberations of the West India Company. M. Francis Louis Bosc de la Calmette has taken the Oath, before the Council of State, as Major and Lieutenant Colonel of the Regiment of Rump, in which he is to rank as Colonel.

*Whitehall, October 13.*

The King has been pleased to grant the Dignity of a Countess of the Kingdom of Great Britain, unto the Right Honourable Hester, Viscountess Cobham, by the Name, Style and Title of Countess Temple ; and the Dignity of Earl Temple to the Heirs Male of her Body.

The King has been pleased to order a Congé d'Elire to pass the Great Seal of Great Britain, empowering the Dean and Chapter of the Cathedral Church of Norwich, to elect a Bishop of that See, the same being now vacant by the Death of Dr. Samuel Lisle, late Bishop thereof : And also to order a Letter under his Majesty's Royal Sign Manual, recommending to the said Dean and Chapter Thomas Hayter, Doctor in Divinity, one of his Majesty's Chaplains in Ordinary, and Prebendary of the Collegiate Church of St. Peter Westminster, to be by them elected Bishop of the said See of Norwich.

The King has been pleased to send his Recommendatory Letter to the Dean and Chapter of the Cathedral Church of St. Paul, London, for Richard Terrick, Doctor in Divinity, to be a Canon Residentiary of the said Cathedral Church, in the room of Dr. Samuel Baker, deceased.
