Naples, March 31.

LL our Troops remain quiet in their Quarters; and there is now no more Talk of augmenting the Forces of this Kingdom, nor of their making any Movements, so that there seems not to have been the least Foundation for the Report of our going speedily to form Camps. Two Tartans sailed Yesterday from this Port for the Adriatick Sea, in order to protect our Commerce, and give Chase to the Corsairs of Barbary.

Turin, April 11. Last Wednesday, the 8th Instant, the Houshold appointed to meet the Insanta on the Frontiers of Spain, set out; they were upwards of Four Hundred Persons, and they will be above a Month on the Road, as that which her Highness is to take over the Mountains is an uncommon one, and hitherto

unpractifed.

Vienna, April 11. Prince Louis of Brunf-wick has taken his Leave of their Imperial Majesties, and will set out in a Day or two sor Wolsenbuttle, from whence he will proceed to Holland.

Copenhagen, April 14. Count Schulin departed this Life Yesterday Noon; his Papers were immediately put under the Seal of the Chancery, and his Danish Majesty sent for Count Berkentin, to give him Orders, as is supposed, for the Administration of Foreign Affairs.

St. Helens, April 14.

This Day Admiral Boscawen arrived here. from the East Indies, with four Ships of the Squadron under his Command, having parted with the others on the 8th, 9th, and 10th Instant in a Gale of Wind. Just before his leaving the Cape of Good Hope, the Centaur, one of the French East India Company's Ships, was cast away nigh that Place, but almost all the People were saved, and about 200 taken on board by Admiral Boscawen.
