Petersbourg, April 15.

Eneral d'Arnimb, the new Minister from the King of Poland, as Elector of Saxony, arrived here. Yesterday from Dresden, and immediately notified his Arrival to the Ministers of the Court,

and to all the Foreign Ministers.

Naples, April 15. On the 7th Instant Adyice was received, that a Neapolitan Tartane, and another from Palermo, laden with Corn, had been taken by five Algerine Xebeques, but] that the Crews of both had found Means to killed by a Musket Ball; whereupon the King gave Orders that the St. Charles Man of War, and the Queen, together with two armed Frigates, should put to Sea immediately, and join our Gallies, in order to cruize against those Corfairs,

Rome, April 18. The Pope's Gallies, which are at Civita Vecchia, have Orders to put to Sea immediately, under the Command of M. Bulli, in order to cruize against the Corsairs of Barbary, who already begin to appear upon the Coasts of the Ecclesiastical State; and besides their usual Complement of Men, 200 Soldiers are ordered to be put on board them.

Parma, April 18. Their Serene Highnesses the Duke and Dutchess set out a few Days ago, with the whole Court, for Colorno, where they

propose to stay about three Months.

Bologne, April 21. We learn from Mantua, that General Pallavicini, the Empress's Minister Plenipotentiary, was set out from thence, after having regulated every Thing concerning that Dutchy and its Capital. And by Letters from Modena we are informed, that the Duke and all his Family were preparing to go to Reggio, to be present at the Fair which is to be held at that City next Month.

Stockholm, April 21. The King has had no Return of his Fever. We learn from Gottenbourg, that our East India Company have receiyed Advice from China, that the Princess Louisa Ulrique, and the Concord, two Ships belonging to that Company, were arrived at

Canton.

Vienna, April 25. Their Imperial Majesties have appointed the Count de Cobenzel to repair to Hanover, to compliment his Britannick Mejesty, in their Name, upon his Arrival in his German Dominions.

Leipsick, April 27. In the Night between the 22d and 23d of this Month, a Fire broke out in the Town of Borna, fituate about two Miles from hence, which confumed almost all the Houses and Churches in that Place; and many of the Inhabitants perished in the Flames.

Copenhagen, April 28. An Express has been fent to France, in order to hasten the Return of the Baron de Bernsdorff, our late Minister to 1 that Court, whom his Majesty has lately appointed Secretary of State for Foreign Affairs, in the Room of the late Count de Schulin.

Ratisbon, April 29. Prince Charles of Lorrain, Governor General of the Low Countries, arrived here on the 25th Instant, under a general Discharge of the Cannon of this City; and having rested here a sew Hours, set sorwards on his Journey to Vienna.

Hanover, May 2. The King of Great Britain, our Sovereign, arrived this Day in per-

fect Health at Herenhausen.

Brussels, May 4. The Prince of Tour make their Escape, except one Man who was Taxis, the Emperor's Principal Commissary to the Diet of the Empire, is arrived in this City.

Hague, May 6. His Serene Highness the Prince of Orange assisted this Day at the Assembly of their High Mightinesses the States of Holland and Westfriesland. The Deputies of the respective Colleges of the Admiralty of these Provinces assembled this Morning, in order to take into Confideration divers Affairs relating to their Department. The Marquess del Puerto, the Spanish Minister, has notified in Form to the States General, the Marriage of the Infanta Dona Maria Antoinette, the King his Master's Sister, to his Serene Highness the Duke of Savoy; and their High Mightinesses have ordered a Letter to be wrote, in their Name, to compliment his Catholick Majesty on that Occasion.
