From Tuesday May 29, to Saturday June 2, 1750.

Naples, May 12. N the 5th Instant died Don Nicholas de Sangro, Captain General of the King's Forces, and the next Day his Corple, accompanied with several Officers, and a Detachment of Troops, was interred with the usual Military Formality. The King has presented the Prince of Camporeale, who is appointed his Ambassador to the Court of Vienna, with 54000 Ducats, towards the Expences of putting himself in a suitable Condition for that Embassy. He has requested of the King two Half Gallies to conduct him to Trieste, but he has not as yet been able to obtain them. The Court continues at Portici, where the second Infanta has been dangerously

Rome, May 16. The Motive of the Arrest, in this City, of the Prince of Filomarino, jun. at the Request of the King of Naples, was, for having run away with a young Lady that had made her Escape out of a Nunnery, to Ginevra and Venice, where he had left her with M. Caraccioli the Pope's Nuncio. The Disagreements between the Pope and the Senate of Vemice, with regard to the Patriarch of Aquilea, were come to such a Pitch as would in all Probability have occasioned an open Rupture, had not the French Court offered her Mediation to reconcile them, which they say has been accepted by both Parties. The 13th Instant, being the Empress's Birth-Day, Cardinal Mellini received the Compliments on that occasion from the College of Cardinals, the Foreign Ministers, Prelates, and Nobility; there were in Person eight Cardinals, Subjects of her Imperial Majesty.

. Florence, May 22. The Empress's Birth-Day was celebrated here on the 13th Instant with the usual Solemnity, on which Occasion Count Richecourt entertained at Dinner the Foreign Ministers, and many of the Nobility, who appeared in their rich Habits; and in the Evening the Cannon of the Castles were fired, and the Fire-Works played off. The same Day the Margrave of Baden Dourlach returned to this City from a Tour he made to Leghorn, Pisa, and Lucca, and, after having observed the Curiolities of this City, let out from hence this Morning on his Journey to Turin, to affift at the Festivals for the Nuptials of the Duke of Savoy and the Infanta of Spain. On the 18th unother Picket of Soldiers, out of the Lorrain Regiment of Foot Guards, deserted from their Duty at one of the Gates of this City. The same Day several Soldiers of the said Regiment; who had formerly deserted, and were taken up again and condemned for several Years to hard Labour, took Occasion to over-power the Cenfinel and the Detachment of Soldiers that guarded them whilst they were at Work, made themselves Masters of their Arms, and attempted their Escape, but were prevented by the City Gates being ordered to be shut; on this Occasion a Corporal was killed, and several Soldiers

wounded. They are now closely confined; and it is thought some of them will be put to Death. Count Richecourt returned last Night from the Confines of Bologna, where he went to confer with Cardinal Doria, the Legat of that City, about the new Road which is making from Florence to Bologna.

Petersbourg, May 19. On the 14th Instant, the Anniversary of the Establishment of the four Regiments of Foot Guards was celebrated here as usual, when all the Officers of those Regiments had the Honour to dine with her Imperial Majesty. Letters have been received here from Ghilan, a Province in Persia, which mention a new Revolution in that Kingdom; alledging, that Ibrahim Schach having had the Misfortune to lose a Battle, had fallen into the Hands of his Enemies, who had caused his Eyes to be put out, and had elected a new Schach in his Room. These Letters add, that the different Factions in that Empire, which were continually waging War with each other, had almost ruined several of their finest Provinces.

Warsaw, May 23. The Dietines for the electing Deputies to the General Diet, commence on the 23d of next Month, as well in Poland as Lithuania, and several Persons are already set out from hence to assist at them; and the opening of the General Diet of this Kingdom is fixed for the 24th of August next.

Turin, May 23. The expected Promotion of the Knights of the Order of the Annunciation is made. There were 16 Vacancies, all which the King has filled up. The Duke of Chablais is at the Head of the List. The rest are old Officers and Men of the first Familles here, but none of them are in the Ministry. It is now declared, that the Chevalier Osorio will be made Secretary of State foon after his Arrival here from Spain. The Marquis Pallavicini de Roma is daily expected here from the Court of Parma, to compliment this Court on the Duke of Savoy's Marriage; after which he is to accompany the Ambassadors of Spain and Naples to Briancon, to meet the Dutches: And the Venetian Ambassador, who is going to the Court of Spain, is to pass through this City in his Way thither, in order to compliment the King on this Occasion.

Stockholm, May 26. On the 15th Instant in the Morning the Prince Successor came hither from Drottningholm, and immediately waited on his Majesty, after which his Highness set out by Water for Waxholm, and having visited the Arsenal and Magazines of that Fortress, returned the next Day to Drottningholm; from whence he set out again this Morning for Nykioping, on his Way to Sudermania, where he proposes visiting the Troops quarteted in that Province. We have nothing remarkable from Finland, every Thing there remaining in perfect Tranquility.

Berlin, June 2. Yesterday the Princes Henry and Ferdinand let out from hence for Prussia 3 and this Morning at Four o'Clock his Majesty,

accompanied

accompanied by Prince Ferdinand of Brunswick, and several General Officers and other Persons of Distinction, took the same Route. His Majesty proposes reaching Stargard this Evening, where Prince Maurice of Anhalt Dessau, Governor of that Place, has been some Days making Preparations for his Majesty's Reception. Last Week died Count Leopold de Schwerin, Major General of Foot, and Colonel of the Regiment of Fusiliers of Wurtemberg.

Paris, June 6. This Court will leave Verfailles the Beginning of next Week for Com-

piegne.

Hague, June 9. By a Ship which arrived last Saturday from Surinam, we are informed, that the Insurrection of the Negroes was quite suppressed by a Company of Burghers, headed by their Captain, who, after coming up with the Rebels, had killed some, and taken several Prisoners, who were carried to Paramaibo, and there executed publickly; the few remaining were so dispersed about the Woods, that it was thought they must perish through Want. The Letters received on this Occasion, attribute the Revolt to the Tyranny of Mons. Thomas, the Man whose Plantation was destroyed, and himfelf and his Family murthered by a Negro Slave, whose Wife Mons. Thomas had taken away, and who, in order to gratify his Revenge, engaged all the other Slaves who were discontented with their Masters, to join with him in his Attempt. Notwithstanding this News, the Troops destined for that Place are to be shipped off in a few Days, and the Officers who are to command them have received Orders to repair immediately to Naarden, where they are now affembled. The Prince of Orange's Departure for Zealand is not yet determined, though it is expected his Serene Highness will set out from hence about the latter End of this Week, or the Beginning of the next. The States of that Province are to allemble on the 15th Instant.

And as a further Encouragement, the Court of Directors of the East India Company do hereby promise a Reward of Twenty Pounds to any Person or Persons making such Discovery, to be paid upon the Conviction of any such Offender or Offenders.

Georgia Office, Westminster, May 25, 1750. Whereas the Trustees for establishing the Colony of Georgia in America, thought it necessary in the first Establishment of that Colony to restrain the Grants they made of Lots of Land to limitted Tenures only, in order thereby to prevent many Abuses which at that Time might probably have deseated the good Ends proposed by that Establishment, and during the late War it might have been of dangerous Consequence to have alter'd the Tenures; but as a general Peace and Tranquility hap-

pily prevail, the said Trustees are of Opinion, that the intended Enlargement of the Tenures may now be safely made, and have come to the following Resolution, viz.

That the Tenures of all Grants of Land what sever already made to any Persons within the Province of Georgia, be enlarg'd and extended to an absolute Inberitance; and that all future Grants of Land shall be of an absolute Inberitance to the Grantees, their Heirs and Assigns.
