Rome, February 6,

HE Prince and Princess of Villafranca arrived here a few Days ago from being introduced to the Pope on Sunday last, and met with a favourable Reception. Orders are issued for taking the necesfary Measures to prevent the running of Tobacco into the Ecclesiastical State, which has lately been carried on more than ever. Such heavy Rains have sallen in this Neighbourhood for this Fortnight past, that the Tiber has again overflown its Banks, and made the Ways impassable, so that many of the Nobility and Gentry, who came here to be present at the closing of the Jubilee, and were about to return Home, are obliged to deser their Departure for the present. The new Ambassador from the Republick of Venice is foon expected here, which gives great Joy to this Court, as the Differences between the Pope and that Republick, in Relation to the Patriarchate of Aquileja, seem now to be adjusted on a solid Footing, and to the mutual Satisfaction of all the Parties concerned in that Affair.

Petersbourg, Feb. 8. Several Engineers are fet out from hence for Livonia, in order to visit the Fortified Places of that Province, and to make fuch Repairs as shall be thought necessary; and Orders are fent to the Governors of Cronstadt, Revel and Fredericksham, for the Equipping with all Diligence the Men of War, Gallies, and other Ships which are to compose the Fleet of this Empire, in order to their being in Readiness to put to Sea as soon as the Baltick

shall be free from Ice.

Genoa, Feb. 10. Last Week four Barbary Corsairs cast Anchor in Sight of Ventimiglia, and fent a Shallop on Shore, which some Country People perceiving, immediately alarmed all the neighbouring Villages; when the Barbarians, finding they were in Danger of being surrounded by Numbers of People, who appeared on all Sides in Arms, reimbarked with great Precipitation, without carrying off the least Booty.

Parma, Feb. 12. The Dutchess is so well recovered from her Lying-in, that she already begins to see Company. The Marquess de Crussol, who is coming hither to reside in Quality of Envoy Extraordinary and Plenipotentiary from his most Christian Majesty, is expected here towards the Beginning of next

Week; and to all Appearance M. Chauvelin will set out about the same Time for Genoa, in order to renew his Functions of Minister from the Court of France to that Republick.

Montpellier, and had the Honour of Prague, Feb. 13. The Recruits for the Imperial Regiments of Horse and Foot quartered in this Kingdom, continue to be raised with fuch Success, that 'tis not doubted but those Regiments will all be compleat by the End of April next. This Week we have had great Diversion of Sledging upon the Snow in the Neighbourhood of this City. On Thursday Field Marshal Prince Lobkowitz, accompanied by a great Number of Persons of Distinction, and Officers of this Garrison, partook of that Diversion: They went in Sledges as far as the Abbey of Konigsaal, where they all dined, from whence they returned in the same Manner at Night, by the Light of a great Number of Flambeaux, and attended by several Musicians, who continued playing all the Way Home, which greatly heightened the Diversion, and made it very agreeable.

> Turin, Feb. 13. Last Thursday his Sardinian Majesty was taken ill of a Fever, and obliged to go to Bed; but Yesterday in the Afternoon he was a great deal better, and at Night there was a Drawing-Room as usual, at which his Royal Highness the Duke and the Princesses appeared. To-day his Majesty is so well recovered as to receive the Foreign Ministers at his Levée. The Beginning of this Week the Marquess de Balbian, Governor of Suze, who was come hither on his private Af-

fairs, died suddenly,

The King continues to enjoy as good a State of Health as his Age will well admit of, and has come to a Resolution of taking a Tour to the Province of Schonen in the Month of May next, in order to have an Interview with the Landgrave of Hesse Cassel, who is to come thither at the same Time for

that Purpose.

Vienna, Feb. 17. A few Days ago a grand Council was held at the Palace, at which their Imperial Majesties assisted. Count Sotobilsky is arrived here from Poland, to take upon him the Office of one of his Imperial Majesty's Chamberlains, to which Employment he was lately appointed. The Emperor has conferred on M. Senckenbourg, Councillor of the Aulick Council, the Title of Baron of the Empire; aud

and his Diploma has been accordingly dispatched to him. The young Count de Preysing, who came here some Days ago to execute a private Commission on the Part of the Elector of Bavaria, is set out from hence on his Return to Munich.

Berlin, Feb. 23. The Distemper amongst the Horned Cattle continuing to make great Havock in the old Marche of Brandenbourg, and particularly at Gardeleben and in its Neighbourhood, Orders have been issued for preventing the Holding of the Annual Fair for the Sale of those Beasts, which used to be on the 2d of March; and all other Precautions are taking to prevent its surther Progress. Prince Maurice of Anhalt Dessau, accompanied by the young Baron de Kleist, and some other Ossicers, arrived here last Night from Potzdam.

Brussels, Feb. 28. By our last Letters from Paris we are informed, that the Dauphin was taken ill, on the 25th Instant, with a Pain in the Head, which was attended with a severish Disorder, occasioned by a Cold; but that he was something better on the 26th, although he

still kept his Bed.

Hague, March 2. The States of Holland and Westfriseland continued to Day their Deliberations in the Presence of his Serene Highness the Prince of Orange. Circular Letters were dispatched this Morning for convoking an Assembly of their High Mightinesses the States General, which is to be held on Tuesday next. Their High Mightinesses have appointed M. de Noorle to be Director of the Domains of Viane, in the Room of the late M. Feith. Yesterday Baron Spaan gave an elegant Entertainment on Occasion of the Anniversary of Princess Caroline's Birth-Day, which was followed by a Ball, at which were present the Duke of Brunswick Wolfenbuttle, the Princes of Bevern and Baden Dourlach, the Lords and Ladies of the Court, and other Persons of the first Distinction. Field Marshal Count Maurice of Nassau arrived here last Night from London.
