Florence, February 7.

OUNT Richecourt, President of the Council of the Regency, fet out a few Days ago for Pifa, from whence he will go to Leghorn, in order to wait the Arrival of the Emperor's three Ships of War, which are expected to return into that Port fome Time next Month, Laft Week a Detachment of our Troops fet out from hence for Leghorn, having under their Care 16 Algerines, being the Crew of a Xebeck which was drove on Shore.by one of the Pope's Pinks near Groffetto, where they had the good Fortune to fave themfelves by taking to their Shallop, and making for the Coaft of Tufcany, -notwithstanding a Bark was immediately fent in Pursuit of them. They are all ordered to be supported at the Expence of the Government, till an Opportunity offers of fending them to Algiers. Petersbourg, Feb. 12. Her Imperial Majesty has raifed Colonel Ifwolsk to the Rank of Brigadier, and at the fame Time declared him President of the Council of Manufactures. The Departure of Count Bernes for Vienna will now foon take Place, he having had his Audiences ' of Leave on Sunday last; and the next Day his Succeffor the Baron the Pretlak was admitted to his first publick Audience of her Imperial Majesty, to whom he delivered his Credential Letters; after which he was likewife admitted to his first publick Audience of the Great Duke and Great Dutches. Notwithstanding the greatest Part of the General and other Officers, who had obtained Leave to pass fome Time here, are returned to their respective Posts, the Court continues extremely brilliant, and there are Abundance of Diversions going forward. The Marriage of Prince Gallitzin with the Princess Cantimir, one of her Imperial Majesty's Ladies of Honour, was celebrated at Court on Tuesday last with great Magnificence. Rome, Feb. 13. On the 8th Inftant Prince Frederick of Deux Ponts arrived here, and on the 10th he was introduced to the Pope; he proposes spending some Days in this City, and then to fet out for Naples. Munich, Feb. 18. The Elector of Cologn has fixed his Departure to the 4th of next Month; and the Cardinal of Bavaria, Prince and Bishop of Liege, proposes to set out from hence about the same Time, in order to return to Manheim. Count Wartensleben, Minister from the States General, is preparing

for a Journey which he proposes to take to Vienna.

Copenhagen, Feb. 20. The King has granted, by his Letters Patent, dated the 10th of last Month, to a private Company at Bergen in Norway, the fole Liberty and Privilege of Refining of Sugars. And in order to contribute to the Success of this Undertaking, his Majesty has caufed an Ordonnance to be published, forbidding the Importation of all Foreign Refined Sugars and Syrups into the Port of Bergen, or any of the Territories thereunto belonging, or into any of the Districts of Norway that correspond with that Port, or receive any Merchandize from thence. A few Days ago his Majesty was pretty much out of Order with a Cold, but he is now perfectly recovered. Captain Hoglandt is appointed to command his Majesty's Ship the Falster of 40, as is Captain Schindel the Dokke of 30 Guns, which two Ships are almost ready to put to Sea, in order to cruize on the Barbary Corfairs in the Mediterranean. Cracow, Feb. 20. We enjoy here, as well as in the whole Kingdom, the greatest Tranquillity; the Tribunal of Petrikau continuing its Seffions with all the Success imaginable; the Divisions which ran very high amongst some of the principal Families, are now entirely ceased ; and all the Advices from Podolia and Lithuania agree, that the Heyducks have not appeared for some Time past upon any of the Frontiers of those Provinces. Vienna, Feb. 20. Her Imperial Majesty advances happily in her Pregnancy, and as her Time begins now to draw near, Publick Prayers for her fafe Delivery are ordered to be put up, not only in all the Churches of this City, but also in all those of the Hereditary Countries. Berlin, Feb. 20. M. Maffow, Colonel of the Regiment of Forcade, has obtained Leave, on Account of his bad State of Health, to refign that Employment; and the King has given his Regiment to the Lieutenant Colonel of the Regiment of Du Moulin. On Tuesday his Majefty accompanied the two Queens to an Entertainment provided for them by the Prince of Pruffia, after which a fine Concert of Mulick was performed; and the next Day the reigning Queen took the Diversion of Coursing on the Snow in a Sledge as far as Schonhausen, being followed by a numerous Retinue. Dresden, Feb. 23. Marshal Lowendahl set out from hence on Tuesday last for Poland; and on Thursday the Duke and Dutchess of Wurtembourg,

tembourg, accompanied by the Margrave of Brandebourg Barenth, arrived here, in order to partake of the Diversions of the Season, which have not for a long Time been so brilliant as they are this Year.

Hague, March 4. Yefterday his Serene Highnefs the Prince of Orange, accompanied by the Prince of Brunfwick Wolfenbuttle, Count Naffau, and feveral other Perfons of Diffinction and General Officers, took a Tour to Delft, in order to ylew the Magazines at that Place, with which they all expressed the utmost Satisfaction. This Morning the Prince of Orange affisted again at a Council of State, when feveral Military Officers, who were lately i preferred by his Serene Highness, took the usual Oaths for their feveral Employments. We hear from Bois-le-Duc, that M. Massing, President of the Regency of that Place, died there on Tuesday last of an Apoplectick Fit.
